Relief for refugees: On the Immigration and Foreigners (Exemption) Order, 2025

India and Sri Lanka must help voluntary **repatriation** of refugees

The **formulation** of the Immigration and Foreigners (Exemption) Order, 2025, notified by the Union Ministry of Home Affairs on September 1, 2025, **provides** greater clarity on certain issues **concerning** India's immigration **framework**. It **exempts** a set of people from the requirement of a valid passport or other valid travel document and valid visa to enter, stay and exit the country. Apart from specified sets of Indian citizens, it covers nationals of Nepal and Bhutan; Tibetan refugees; six religious minorities from Afghanistan, Bangladesh and Pakistan, and Sri Lankan Tamils. A significant **aspect** is the reference to the Sri Lankan Tamil refugees, with many living in Tamil Nadu since 1990. The order protects them from forcible repatriation to Sri Lanka, the **stipulations** being that they should have **taken shelter** in the country as on January 9, 2015 and registered themselves. In the last 30-odd years, neither the Union government nor the Tamil Nadu government had **drawn up** any **unilateral** plan to send them back. In fact, after the end of the **civil war** in Sri Lanka in 2009, both the governments have been **doing their bit** to ensure their welfare. Yet, Sri Lankan Tamils were not included when the Union government **amended** the Citizenship Act six years ago to provide citizenship to the six non-Muslim groups from three Muslim-majority countries. Thus, the order gives Tamil refugees some relief.

However, there are unanswered questions. It is not clear whether the refugees will be able to **shake off** their "illegal migrants" tag. A **hurdle** in their applying for Indian citizenship — by registration under Section 5 of the Citizenship Act, 1955 or by **naturalisation** under Section 6 of the Act **is** that they are 'illegal migrants' as per the law. When the refugees are not considered eligible to apply for a Long Term Visa (LTV) it is doubtful whether they will be able to **seek** citizenship. LTVs will enable their gainful employment and higher education. **In the run-up to** the **enactment** of the Citizenship Amendment Act, 2009, the Ministry had justified their exclusion and had taken the stand that they were among those eligible for LTVs if they could prove that they had been "victims of **oppression** in their countries of origin...." The Centre would do well if it **liberalised** its stand on LTVs for the deserving among the Sri Lankan Tamil refugees. The **certificate** of identity for Tibetan refugees **can** be a model. It is also time that India and Sri Lanka took early steps for voluntary repatriation along with a scheme of **structured assistance**. Local **integration** is also an option to **sort out** the issue. Fundamentally, the **stakeholders** should adopt a **humane** approach.

Summary of the Editorial

- 1. The Immigration and Foreigners (Exemption) Order, 2025, was notified by India's Ministry of Home Affairs on September 1, 2025.
- 2. It clarifies exemptions from passport and visa requirements for certain groups to enter, stay, or exit India.
- 3. Beneficiaries include nationals of Nepal and Bhutan, Tibetan refugees, six minority groups from Afghanistan, Bangladesh, and Pakistan, and Sri Lankan Tamils.
- 4. A key feature is the inclusion of Sri Lankan Tamil refugees, many of whom have lived in Tamil Nadu since 1990.
- 5. The order protects them from forcible repatriation, provided they were sheltered in India before January 9, 2015, and are registered.
- 6. Neither the Union government nor Tamil Nadu had attempted forced repatriation in the last three decades.
- 7. Since the end of Sri Lanka's civil war in 2009, both governments have focused on welfare measures for these refugees.
- 8. However, Sri Lankan Tamils were excluded from the 2019 Citizenship Amendment Act, which granted citizenship to other persecuted groups.
- 9. The new order offers relief but leaves ambiguity about their "illegal migrant" status.
- 10. Under current law, their "illegal migrant" tag blocks them from applying for Indian citizenship under Sections 5 and 6 of the Citizenship Act.
- 11. Their ineligibility for Long Term Visas (LTVs) further restricts access to higher education and employment.
- 12. Earlier, the Centre argued that Sri Lankan Tamils could get LTVs if they proved persecution in their country of origin.
- 13. A liberalised approach to LTVs for deserving Sri Lankan Tamil refugees could help, with the Tibetan refugee identity certificate as a model.
- 14. India and Sri Lanka should work together on voluntary repatriation supported by structured assistance.
- 15. Ultimately, a humane approach involving options like repatriation or local integration is needed to resolve the issue.

- d: This sentence now explains the reason why it's "not quiet" as mentioned in sentence 'b'. It elaborates on the source of the noise/disturbance. Moreover, the use of the phrase "a half-a-km radius" indicates the effect of the dog's barking.
- c: This sentence is a direct consequence of the dog's barking from sentence 'd'. After the initial dog has barked, other dogs respond. The use of the phrase "a half-a-km radius" again provides continuity and confirms the sequence.

 - हाँ/क्यों: Yes/No प्रश्न में if/whether आता है; "Can I" → he could; "this" → that; "will" → would; "Sir" का भाव respectfully से बना रहता है।

Why the others are wrong (brief):

- A: "asked that could he ..." (wrong structure; no "that" in reported questions; inversion kept); "will" not backshifted.
- B: "told" can't report a question; no backshift ("can"); missing "department" and article; style faulty.
- C: "wondered can he ..." keeps inversion; "would got" ungrammatical.
- 19. D) Specific (adjective) Exact, distinct, detailed, definite, explicit विशिष्ट

Synonym: Precise (adjective) – Clearly expressed, accurate, exact, definite, correct सटीक

- **Proper** (adjective) Suitable, appropriate, correct, fitting. उपयुक्त
- Uncommon (adjective) Rare, unusual, exceptional, extraordinary. असामान्य
- Noteworthy (adjective) Significant, remarkable, notable, extraordinary. उल्लेखनीय

20. A) **EBCAD**

E: The logical starting point appears to be sentence E, as it introduces the issue (lack of social security benefits for a majority of the salaried workforce) and mentions a specific source - the "Periodic Labour Force Survey Annual Report 2021-22".

B: Sentence B uses the word "such employees," which can be a reference to the salaried workforce mentioned in sentence E. Hence, B logically follows E

C: Sentence C mentions "Another conclusion", indicating that there was a previous conclusion or statement related to workforce benefits.

A: The use of "Meanwhile" in A acts as a transitional word, indicating a switch in focus from the previous group (poorest 20% quintile) to another segment of the workforce (gig workers).

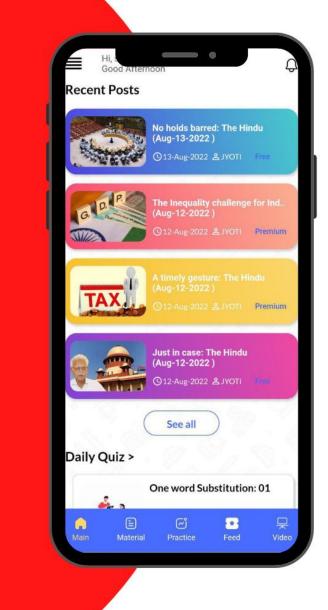
- D: After discussing specifics about various segments of India's workforce, sentence D provides a broader context by discussing India's ranking in social security on an international scale. The mention of the ranking (40 out of 43 countries in 2021) offers a more generalized picture after discussing the specific groups
- 21. C) **'Envisaged'** का use होगा क्योंकि "envisaged" past participle है और यहाँ "by the Narendra Modi government" के साथ passive, reduced relative clause बनाया गया है: "The Great Nicobar Island Project, envisaged by...". इसलिए 'envisaged' सही है। जबकि 'envisage' (base form) और 'envisages' (simple present active) "by" के साथ passive नहीं बनाते, और 'envisaging' (present participle) के साथ "by" लगाना व्याकरणतः असंगत है।
 - **'Envisaged'** will be used because it's a past participle forming a passive reduced relative clause with "by the Narendra Modi government." Hence it fits the structure "Project, envisaged by...". In contrast, 'envisage' (base form) and 'envisages' (simple present

- active) don't create the required passive with "by," and 'envisaging' paired with "by" is grammatically inappropriate here.
- 22. B) 'an' का use होगा क्योंकि "ambitious" vowel sound (/æm-/) से शुरू होता है और singular countable noun "project" के लिए अनिश्चित article चाहिए; इसलिए clause "is an ambitious project" व्याकरण की दृष्टि से सही predicate complement बनता है। जबकि 'a' consonant sound से पहले आता, 'the' definite article है—यहाँ पहले से निर्दिष्ट कोई विशेष "ambitious project" नहीं है, और 'no article' गलत है क्योंकि singular countable noun को किसी determiner की आवश्यकता होती है।
 - 'an' will be used because "ambitious" begins with a vowel sound (/æm-/), and a singular countable noun "project" needs an indefinite article; thus "is an ambitious project" is grammatically correct as the predicate complement. Whereas, 'a' is for consonant sounds, 'the' is definite (no previously identified specific "ambitious project" here), and 'no article' is wrong because singular countable nouns require a determiner.
- 23. D) '**Is'** का use होगा क्योंकि "The project" एक singular subject है और वाक्य वर्तमान सामान्य (present simple) passive में सच/स्थायी तथ्य बताता है: "is designed...". बीच के कॉमा-वाले phrase (of strategic, defence and national importance) subject की संख्या नहीं बदलता। जबकि 'are' plural verb है, 'were' past + plural sense देता है, और 'was' past singular है जो पहले के frame "is ... ambitious project" (present) से टकराता है।
 - 'Is' will be used because it forms the present simple passive "is designed...", stating a current fact about a singular subject "The project". The commaed appositive does not affect subject number. Whereas, 'are' is a plural verb (number mismatch), 'were' is past/plural, and 'was' is past singular, clashing with the present framing earlier ("is ... ambitious project").
- 24. A) 'Poses' का use होगा क्योंकि "pose (a threat)" का अर्थ होता है किसी जोखिम/खतरे को प्रस्तुत करना। sentence में mention किया गया है कि परियोजना जनजातीय समूहों को कोई खतरा प्रस्तुत नहीं करती, इसलिए 'poses' यहाँ सही है। यह grammatically भी सही है: singular subject 'project' → 'poses', और fixed collocation 'pose a/no threat' होता है। जबिक 'Alleviates' का अर्थ है कम करना/राहत देना, 'Lessens' का अर्थ है घटाना, और 'Vilifies' का अर्थ है बदनाम करना—ये 'no threat' के साथ न अर्थ में फिट बैठते हैं न collocation के रूप में सही हैं।
 - 'Poses' will be used because 'pose (a threat)' means to present a risk/danger. The sentence states that the project presents no threat to tribal groups, so 'poses' fits. It's also grammatically correct: singular subject 'project' takes 'poses', and the fixed collocation is 'pose a/no threat'. Whereas, 'Alleviates' means to reduce/relieve, 'Lessens' means to decrease, and 'Vilifies' means to malign/defame; these don't collocate with 'no threat' and don't suit the context.
- 25. D) 'Jeopardise' का use होगा क्योंकि "jeopardise" का अर्थ होता है किसी चीज़ को जोखिम/खतरे में डालना। sentence में कहा गया है "does not jeopardise the eco-sensitivity", यानी परियोजना पर्यावरणीय संवेदनशीलता को ख़तरे में नहीं डालती; इसलिए यह सही है। साथ ही यहाँ "does not + base verb" संरचना है और 'jeopardise' एक transitive verb है जो 'eco-sensitivity' को

object लेता है। जबिक 'safeguard' का अर्थ संरक्षण करना है—"does not safeguard" उल्टा अर्थ देगा; 'condone' का अर्थ गलत को मौन स्वीकृति देना है; और 'delineate' का अर्थ स्पष्ट रूप से वर्णन/रेखांकन करना है—ये सब इस context और object के साथ फिट नहीं होते।

• 'Jeopardise' will be used because it means to endanger/put at risk. The sentence asserts the project "does not jeopardise the eco-sensitivity," which fits the intended meaning and the "does not + base verb" grammar; 'jeopardise' is a transitive verb correctly taking "eco-sensitivity" as its object. Whereas, 'safeguard' means protect (and "does not safeguard" would imply the opposite of the author's positive claim), 'condone' means tacitly approve wrongdoing, and 'delineate' means describe/outline—none match the risk/harm sense or collocate naturally with "eco-sensitivity."
