# H-1B, maybe: On Donald Trump and the H-1B visa fees hike

India's tech workers must reduce their reliance on U.S. jobs

President Donald Trump's decision to charge new applicants for the H-1B highly skilled non-immigrant visa \$100,000, nearly six times the current fee, has caused widespread consternation that not only might the lives of tens of thousands of potential visa applicants in the tech space be impacted, leading to "humanitarian consequences" for families, as mentioned by India's Ministry of External Affairs, but there will also be widespread **disruption** among major tech companies in the U.S. that **rely** on hiring skilled workers under this visa. While the number of visas issued in this category has been capped at 85,000 per year since 2004, and allocations are decided through a lottery, reports based on U.S. Citizenship and Immigration Services data suggest that applications for the upcoming fiscal year have dropped to a four-year low of nearly 3,59,000. Indian nationals typically account for 71% of these visas, yet data also suggest that close to 60% of these visa recipients earn less than \$100,000, which, over the longer term, implies that their employers may find it harder to justify hiring such specialised workers from abroad. The External Affairs Ministry's response to the White House action included a reiteration of the fact that "Skilled talent mobility and exchanges have contributed enormously to technology development, innovation, economic growth, competitiveness and wealth creation in the U.S. and India", yet there is limited scope for **South Block** to apply pressure, **diplomatic** or political, to get the policy reversed.

However, the fallout for Indian citizens can be contained if there is a proactive approach by the Government to bolster India's infrastructure and undertake necessary reforms to improve the prospects for the Indian tech industry to make even greater strides than it has done so far. This might be achieved by capitalising on opportunities to develop new capabilities in the Artificial Intelligence space and exploring new markets across Asia, including China and Russia, and in parts of Europe, where the transatlantic contagion of nativist protectionism has not yet found willing takers. While the Trump order is set to expire within a year, there is no guarantee that it would not be extended, making it all the more pertinent for policymakers in India to evolve a long-term plan to reduce reliance of Indian tech workers on the shrinking pool of job opportunities in the U.S. economy. As India and other countries adjust to this new reality of the hostility of the Trump White House to welcoming future innovators, job-creators, and tax-payers to their shores, it is the U.S. rather than other nations that will suffer a shortage of scientific and engineering prowess to fuel economic progress.

## **Explanations**

#### 1. A) Analytical

B is correct because the subject "decision" is singular and takes the singular verb has caused.

A is incorrect because "have caused" is plural, but the subject is singular.

C is incorrect because "causing" makes the sentence incomplete (a fragment, no main verb).

D is incorrect because "are causing" mismatches the singular subject "decision."

#### 3. D) Compound-Complex Sentence

A is wrong because wealthy American citizens are not directly affected by H-1B policy.

C is wrong because the hike reduces opportunities, not guarantees them.

D is wrong because the 85,000 visa cap remains unchanged.

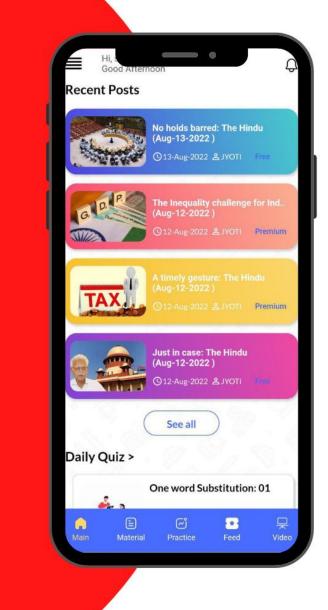

B) 'Constraints' का use होगा क्योंकि "constraints" का अर्थ होता है सीमाएँ या बाधाएँ। sentence में mention किया गया है कि PhD students पहले से ही resource limitations से suffer करते हैं, इसलिए 'constraints' यहाँ बिल्कुल सही बैठता है। जबकि 'Autonomy' का अर्थ है स्वतंत्रता या स्वशासन, 'Wastrel' का अर्थ है फिजूलखर्च व्यक्ति, और 'Tapestry' का अर्थ है कढ़ाईदार वस्त्र या विविधता का मिश्रण, जो इस context में resource limitation को व्यक्त नहीं करते।
  - 'Constraints' will be used because it means limitations or restrictions. The sentence states that PhD students already suffer from resource shortages, making 'constraints' contextually and grammatically correct. Whereas, 'Autonomy' means independence, 'Wastrel' means a wasteful person, and 'Tapestry' means a woven fabric or mixture of elements, none of which express the idea of resource shortage.
- 22. A) **Norm'** का use होगा क्योंकि "norm" का अर्थ होता है सामान्य मानक या accepted standard. Sentence में बताया गया है कि इतने resource constraints के बावजूद छात्रों से papers के लिए इतना पैसा खर्च करवाना सामान्य मानक (norm) नहीं हो सकता। इसलिए 'norm' यहाँ सही है। जबिक 'angst' का अर्थ है चिंता या डर, 'douse' का अर्थ है बुझाना, और 'edict' का अर्थ है सरकारी आदेश या decree, जो इस context में logically और grammatically फिट नहीं होते।
  - 'Norm' will be used because it means a standard or accepted way of doing things. The sentence highlights that asking students with limited resources to pay such high amounts cannot be the norm, making 'norm' correct here. Whereas, 'angst' means fear or anxiety, 'douse' means to extinguish, and 'edict' means an official order, which do not fit
- 23. B) **The'** का use होगा क्योंकि यहाँ Delhi High Court एक specific संस्था है। किसी particular जगह, संस्था या body को refer करने के लिए हमेशा definite article "the" लगाया जाता है। इसलिए यहाँ सही उत्तर the Delhi High Court है। जबिक 'A' का अर्थ होता है "कोई एक", जो यहाँ उपयुक्त नहीं है; 'An' vowel sound से पहले आता है, पर यहाँ proper noun है; और 'No article' लगाने से वाक्य अधूरा और grammatically incorrect हो जाएगा।
  - 'The' will be used because "Delhi High Court" is a specific institution. For a particular place, institution, or body, the definite article "the" is always used. Hence, the correct usage is the Delhi High Court. Whereas 'A' means "any one," which is not appropriate here; 'An' is used before vowel sounds, but this is a proper noun; and 'No article' would make the sentence incomplete and grammatically incorrect.
- 24. D) 'Triggered' का use होगा क्योंकि यह Past tense में है और sentence की main घटना को describe कर रहा है कि "High Court ने sites block कीं और इसने एक debate को triggered किया।" यहाँ completed action है इसलिए past form ज़रूरी है। जबकि 'Trigger' base verb है जो

tense से match नहीं करता, 'Triggering' participle/continuous form है जो यहाँ सही नहीं बैठेगा, और 'Triggers' present tense है जो past घटना से मेल नहीं खाता।

- 'Triggered' will be used because it is in past tense and the sentence is describing a completed action the blocking of sites triggered a debate. Since the High Court order happened in the past, past tense is required. Whereas, 'Trigger' is the base form and doesn't fit grammatically, 'Triggering' is a participle/continuous form unsuitable here, and 'Triggers' is present tense, which does not match with the past event.
- 25. C) **Grounds'** का use होगा क्योंकि "grounds" का अर्थ होता है किसी कार्य के पीछे का कारण या आधार। sentence में mention किया गया है कि sites को copyright infringement के grounds पर block किया गया, इसलिए 'grounds' यहाँ सही है। जबिक 'Baselessness' का अर्थ है बिना आधार के होना, 'Invalidity' का अर्थ है अमान्यता, और 'Glean' का अर्थ है इकट्ठा करना, जो इस context में सही नहीं है।
  - 'Grounds' will be used because it means the reason or basis for an action. The sentence mentions that the sites were blocked on the grounds of copyright infringement, making 'grounds' fitting here. Whereas, 'Baselessness' means lack of basis, 'Invalidity' means nullity, and 'Glean' means to collect, which don't fit in this context.
