Fire at Jaipur's Sawai Mansingh Hospital

The **fragility** of India's public-hospital safety **architecture was cast into sharp relief** once again Sunday night when a fire **broke out** in the neurosurgery ICU of Jaipur's Sawai Mansingh (SMS) Hospital, one of the largest government hospitals in Rajasthan. **The blaze**, **reportedly triggered** by a short circuit in an **adjacent** storage room, **claimed** the lives of at least six critically ill patients. Eyewitnesses and **bereaved** families speak of horrifying scenes of **chaos**: **Malfunctioning** alarms, absent fire extinguishers, locked emergency exits, overburdened staff ignoring early warning signs before **abandoning** patients and their **desperate** attendants in the **pandemonium** that followed. In an institution meant to offer care, this failure of basic infrastructure, **preparedness** and **accountability reinforces** a deeper **chasm** — one of **chronic** neglect and institutional **inertia**.

That the SMS Hospital tragedy is not an outlier in India's recent history of hospital fires is evident from the fact that around the same time as the disaster in Jaipur, in Ahmedabad, in two separate incidents, fire broke out at a children's hospital on Sunday and at another municipal-run hospital on Monday. An investigation by this newspaper into major fires across 11 hospitals in the last five years, following the death of 18 newborn babies in a hospital fire in Jhansi in November 2024, had revealed an alarming pattern: Short circuits caused by inadequate maintenance and improper storage of highly inflammable and hazardous equipment, lack of firefighting equipment and training in evacuation protocols, and negligence of government agencies to conduct audits and enforce compliance. Municipal fire inspections are perfunctory; certifications are rubber-stamped; NDMA and building-code guidelines lurch from paper to oblivion. In the aftermath of Sunday's incident, investigations have revealed that the SMS Hospital has been the site of several incidents of fire, including as recently as June.

The Rajasthan government has **instituted** a six-member committee to investigate the circumstances of the fire. The reaction joins a long **catalogue** of such responses that are not **backed** by consequences. In nearly all of the major fire incidents in the last five years, **most** of **the accused** — hospital owners, administrators and service providers — **have** been granted bail, slipping back into professional life as though no disaster had ever intervened. It signals **impunity**, and a devastating **indifference to** human life, especially that of the poor, who depend mostly on public hospitals. Until accountability becomes **systemic** and **consistent**, the next disaster is not a question of "if" but "when".

Summary of the Editorial

- 1. A fire broke out in the neurosurgery ICU of Jaipur's Sawai Mansingh (SMS) Hospital, one of Rajasthan's largest public hospitals.

- 9. The probe also found lack of firefighting equipment, poor staff training, and negligence by government agencies in enforcing safety norms.
- 10. Municipal fire inspections are often superficial, and safety certifications are routinely rubber-stamped without real checks.
- 11. NDMA and building-code guidelines exist only on paper, rarely implemented in practice.
- 12. Investigations have shown that SMS Hospital itself faced multiple fire incidents before, including one as recent as June 2025.
- 13. The Rajasthan government has formed a six-member committee to investigate the fire's causes.
- 14. However, such committees rarely lead to accountability, as past fire incident accused hospital owners and officials often get bail and return to work unpunished.
- 15. The editorial concludes that unless systemic and consistent accountability is enforced, future hospital fires are inevitable, making it a question of "when" rather than "if."

 - 'Believe' should be used as the sentence is in simple present tense. It states that some experts believe animals' more acute hearing helps them to hear or feel the earth's vibrations. 'Believed' is past tense, 'believing' is the continuous form, and 'are believing' is present continuous tense, which don't fit in this context

- 23. C) Them' का use होगा क्योंकि यहाँ वाक्य में "animals' more acute hearing" की बात हो रही है जो "helps" को refer करता है, इसलिए "them" यहाँ animals को refer कर रहा है। 'Us' और 'They' यहाँ अनुपयुक्त हैं क्योंकि वे humans को refer करते हैं, न कि animals को। 'One' भी गलत है क्योंकि यह general sense में प्रयोग होता है, न कि किसी specific group को refer करने के लिए
 - 'Them' should be used because the sentence refers to "animals' more acute hearing" which helps, so "them" here refers to the animals. 'Us' and 'They' are inappropriate here as they refer to humans, not animals. 'One' is also incorrect as it is used in a general sense, not to refer to a specific group.
- 24. B) They' सही option होगा क्योंकि यहाँ वाक्य के subject 'animals' के लिए एक pronoun की आवश्यकता है जो plural हो। 'They' का अर्थ है 'वे', जो 'animals' को refer कर रहा है। जबकि 'We' का अर्थ है 'हम', 'Them' का अर्थ है 'उन्हें', और 'You' का अर्थ है 'तुम' या 'आप', जो इस context में सही नहीं हैं।
 - 'They' is the correct option because the sentence requires a pronoun for the subject 'animals', which is plural. 'They' refers to 'animals'. Whereas, 'We' means 'us', 'Them' means 'them', and 'You' means 'you', which don't fit in this context
- 25. C) ' realise का use किया जाएगा क्योंकि "realise" का अर्थ होता है किसी बात को समझना या अहसास करना। वाक्य में उल्लेख किया गया है कि जानवर आने वाली आपदा को मानवों से पहले महसूस कर सकते हैं, इसलिए 'realise' यहाँ सही है। जबकि 'Restore' का अर्थ है पुनः स्थापित करना, 'Reflect' का अर्थ है प्रतिबिंबित करना, और 'Renew' का अर्थ है नवीनीकरण करना, जो इस संदरभ में सही नहीं हैं
 - realise should be chosen because "realise" means to understand or become aware of something. The sentence mentions that animals can sense an approaching disaster long before humans realise what's going on, making 'realise' appropriate here. Whereas, 'Restore' means to bring back, 'Reflect' means to mirror or show, and 'Renew' means to make new again, which are not suitable in this context.
