Crime patterns: On the National Crime Records Bureau's report for 2023

The 2023 NCRB report shows a sharp rise in cybercrime and crimes against tribals

The National Crime Records Bureau's annual reports on crime and prison statistics have to be read with a strong caveat — most of the numbers cannot be compared between States because they are largely dependent upon the registration/reporting of crimes in the first place. However, certain national trends and sharp year-on-year changes within States can still reveal meaningful patterns that could demand policy intervention. The recent NCRB report for 2023 — delayed by a year — points to a worrying trend of postponed surveys, reports and even the Census under the current Union Government. But there are also three telling numbers: the 2.8% decrease in murder cases across the country; a staggering 28.8% surge in crimes against Scheduled Tribes (ST), and a 31.2% increase in cyber crimes. While the decrease in murder cases will come as a relief to law enforcement — most of the cases **pertain to** disputes, personal **vendetta** or **enmity** and "gain" — the other two numbers are alarming. The steep rise in crimes against STs is largely due to the ethnic violence in Manipur, with the registered numbers jumping from just one in 2022 to 3,399 in 2023 — which a more effective government could have mitigated. Madhya Pradesh and Rajasthan also recorded significantly high crime rates against tribals suggesting their vulnerability in the central Indian States. This is not a new phenomenon; previous NCRB reports have highlighted higher crime rates in regions with significant tribal populations.

With greater Internet penetration across the country, there has been an increase in cybercrime, particularly related to financial fraud and sexual exploitation. Anecdotally, it is evident that these numbers must have gone up even further in the last two years with the greater use of digital financial instruments in daily transactions and investment. While policing has tried to keep up with the growing menace of cybercrime, with specialised cells, the ubiquitousness and deepening spread of digital crimes require more sophistication and dedication by the police to tackle them. Crimes against children rose by 9.2% in 2023 — with the offender known to the victim in 96% of the cases. While the increase could be a function of improved reporting across States, the high number (1,77,335 cases) suggests that States must work on a war footing to sensitise children about these crimes and inappropriate behaviour by adults. A subset of these crimes could also include the application of the POCSO Act in the case of consensual adolescent relationships and this is an area that needs to be carefully handled by the prosecuting and policing agencies. Reported crimes against women registered a modest increase of 0.4%, but this masks a 14.9% spike in dowry-related crimes, pointing to a persistent societal problem.

- 1. The National Crime Records Bureau (NCRB) released its 2023 report, showing notable trends in various categories of crime.

1. C) the registration/reporting of crimes in the first place

The very first line stresses that most numbers "are largely dependent upon the registration/reporting of crimes in the first place," so cross-State comparisons are unreliable.

- Policing strength may vary, but the passage pins comparability on reporting/registration, not manpower.

"Have you come" (Present Perfect) is changed to "had come" (Past Perfect) in Indirect Speech. The salutation "Dear daughter" is omitted in the Reporting Clause as it is informal. "Caressing her daughter's cheeks" is retained as is in the Reporting Clause.
- 17. A) The correct spelling is 'Continuum' which means "a continuous sequence or range" सातत्य/निरंतर क्रम.
- 18. C) He said to me, "What can I do for you, dear?"

 यह वाक्य Indirect Speech में है। इसे Direct Speech में बदलने के लिए निम्नलिखित चरणों का पालन किया जाता है: Indirect वाक्य में "asked me affectionately" को Direct Speech में बदलते समय "said to me, '...' dear" में बदला गया। "what he could do for me" को Direct Speech में बदलते समय, "he" को "I" और "could" को "can" में बदला गया क्योंकि यह अनुरूपता और वाक्य संरचना के अनुसार है। वाक्य में affectionately (स्नेहपूर्वक) का संकेत "dear" से किया गया है।
 - This sentence is in Indirect Speech and needs to be transformed into Direct Speech. The steps are as follows: The phrase "asked me affectionately" in Indirect Speech becomes "said to me, '...' dear" in Direct Speech. The clause "what he could do for me" is transformed into "What can I do for you" in Direct Speech. The pronoun "he" changes to "I," and "could" changes to "can" to maintain grammatical correctness and context. The affectionate tone is retained with the use of "dear" in the Direct Speech.

 - Inflow (noun) The act of flowing in, influx, entry, arrival. आगमन / आवक

20. A) **CADB**

R starts the paragraph by introducing the role of journalists—"we have the privilege and responsibility of witnessing and writing the first draft of history." This sets the context for the challenges journalists face.

C follows R because it logically extends the idea of responsibility by describing what journalists do—"We rush in to locations where others desperately try to move away from..." This connects with "witnessing" from R, showing the action journalists take.

A comes after C as it contrasts the passion for storytelling with the emotional toll of covering tragedies—"Though the passion to keep telling stories keeps us going, big tragedies leave us with scars..." This builds on the idea of journalists entering disaster zones (C) and the personal impact it has.

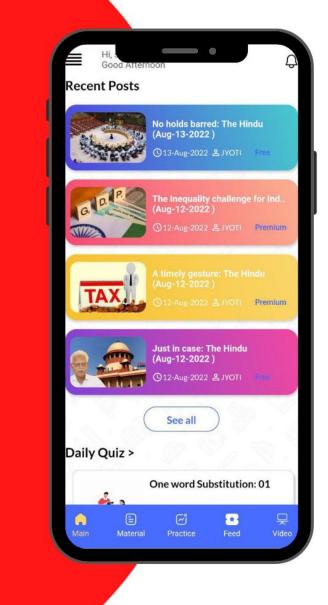
D introduces specific tragedies—"The Mumbai blasts of 2006 and the Malegaon blasts of 2008..."—which connects to "big tragedies" in A, giving real-life examples of the scars mentioned.

B concludes by reflecting on recent court judgments related to these tragedies—"Hearing the two court judgments in these cases..."—referring back to the Mumbai and Malegaon blasts (D) and showing the lasting impact on victims and accused.

In Hindi:

- R paragraph की शुरुआत करता है, क्योंकि यह journalists की भूमिका को introduce करता है—"we have the privilege and responsibility..."
- C, R के बाद आता है क्योंकि यह बताता है कि journalists क्या करते हैं—"We rush in to locations..." यह R के "witnessing" से जुड़ता है।
- A, C के बाद आता है क्योंकि यह passion और emotional scars के बीच contrast देता है—"big tragedies leave us with scars..."
- D, A के बाद आता है क्योंकि यह specific tragedies (Mumbai/Malegaon blasts) की introduce करता है, जो A के "big tragedies" से connect होता है।
- B last में आता है क्योंकि यह court judgments के बारे में बताता है, जो D में mentioned tragedies से related हैं।
- 21. C) 'also' का प्रयोग होगा क्योंकि यहाँ बताया गया है कि नर्मदा नदी को रेवा के नाम से भी जाना जाता है। यह शब्द एक अतिरिक्त जानकारी या समानता की जानकारी देता है 'but' का अर्थ होता है लेकिन, जो यहाँ उपयुक्त नहीं है क्योंकि हम किसी विरोधाभास की बात नहीं कर रहे हैं। or' का प्रयोग विकल्पों में से चयन के लिए होता है, जो इस संदर्भ में सही नहीं है। And' का उपयोग दो वस्तुओं या विचारों को जोड़ने के लिए होता है, पर यहाँ कोई जोड़ नहीं है बल्कि एक ही नदी के दो नाम बताए गए हैं।
 - 'also' should be used because it indicates that the Narmada River is additionally known as Rewa. This word provides information on an additional or similar name 'but' means 'but', which is not suitable here because we are not discussing a contradiction. 'or' is used for selecting among alternatives, which is not correct in this context. And' is used to connect two items or ideas, but here there is no connection but rather two names of the same river are given.

- 22. B) **as'** का use होगा क्योंकि यह विकल्प नर्मदा नदी के एक और नाम 'Nerbudda' के रूप में पहचाने जाने की स्थिति को दर्शाता है। 'as' का प्रयोग जब हम किसी व्यक्ति, जगह या चीज़ को किसी विशेष नाम या उपाधि से जानते हैं, तब किया जाता है। इसलिए, "known as Nerbudda" सही है. जिसका मतलब है कि नर्मदा नदी को पहले 'Nerbudda' के रूप में जाना जाता था।
 - 'as' should be used because it indicates the situation where the Narmada River is recognized by another name, 'Nerbudda'. The use of 'as' applies when we refer to a person, place, or thing by a specific name or title. Therefore, "known as Nerbudda" is correct, implying that the Narmada River was previously recognized as 'Nerbudda'.
- 23. B) 'with' का use होगा क्योंकि इसका अर्थ है 'साथ में' या 'के साथ', जो इंगित करता है कि Narmada River के साथ Godavari और Krishna नदियाँ भी शामिल हैं। Sentence की संरचना से पता चलता है कि यह एक समानता या सूचीबद्धता की बात कर रहा है, इसलिए 'with' यहाँ सही है। 'To', 'by', और 'Beside' इस context में सही नहीं हैं क्योंकि 'to' का अर्थ होता है 'की ओर', 'by' का अर्थ होता है 'द्वारा', और 'Beside' का अर्थ होता है 'के बगल में', जो यहाँ परिस्थिति के अनुरूप नहीं हैं।
 - 'with' should be used because it means 'together with' or 'including', indicating that along with the Narmada River, the Godavari and Krishna rivers are also included. The sentence structure indicates a comparison or a listing, making 'with' fitting here. 'To', 'by', and 'Beside' are incorrect in this context because 'to' suggests direction towards, 'by' implies a method or means, and 'Beside' means 'next to', which do not suit the situation described
- 24. C) **Known'** का use होगा क्योंकि 'known' का अर्थ है किसी विशेषता या पहचान के लिए प्रसिद्ध होना। Sentence में यह कहा गया है कि नर्मदा नदी गुजरात और मध्य प्रदेश के लिए उसके महत्वपूर्ण योगदान के लिए "Life Line" के रूप में जानी जाती है, इसलिए 'known' यहाँ सही है। 'Told' और 'Spoken' का इस्तेमाल जब किया जाता है जब किसी व्यक्ति द्वारा कुछ कहा गया हो और 'Said' का इस्तेमाल भी बोलने के सन्दर्भ में होता है, जो इस context में सही नहीं है
 - **'Known'** should be used because it means being famous or recognized for a particular characteristic or identity. The sentence mentions that the Narmada River is also known as the "Life Line of Gujarat and Madhya Pradesh" for its significant contribution to these states, making 'known' fitting here. 'Told' and 'Spoken' are used when something is said by someone, and 'Said' is also used in the context of speaking, which don't fit in this context.
- 25. D) 'Contribution' का चयन होगा क्योंकि 'contribution' का अर्थ होता है कुछ में योगदान देना।
 Narmada River गुजरात और मध्य प्रदेश के लिए अपने जल संसाधनों के माध्यम से बहुत
 महत्वपूर्ण योगदान देती है, जैसे कि सिंचाई, पेयजल, और ऊर्जा उत्पादन। इसलिए, 'contribution'
 यहाँ सबसे उपयुक्त शब्द है।
 - 'Contribution' should be used because it means to give something as a part of a whole.
 The Narmada River contributes significantly to Gujarat and Madhya Pradesh through its water resources for irrigation, drinking water, and power generation. Hence, 'contribution' is the most appropriate word here.
