Refugees and infiltrators: On different yardsticks for India's refugee community

India needs a refugee policy document that is non-discriminatory

Union Home Minister Amit Shah has rightly stressed the need to make a distinction between refugees and infiltrators. Though valid, the problem lies in the application of objective parameters by those in power to make a distinction. Even where proper policy and a legal framework exist, issues may arise. Also at play is the level of official understanding. In India, which is not a signatory to the 1951 UN Convention on the Status of Refugees and the 1967 Protocol, there is no comprehensive single law defining who a refugee is, leaving scope for arbitrary action. Till the end of March 2025, apart from the Citizenship Act 1955 and the Passports Act 1967, three laws (the Foreigners Act, 1946, the Registration of Foreigners Act, 1939 and the Passport (Entry into India) Act, 1920) were applied to deal with foreign nationals, including refuge seekers. From April, the Immigration and Foreigners Act replaced the three pre-Independence laws and subsumed the Immigration (Carriers' Liability) Act, 2000. While this **streamlined** the legal framework, the **absence** of a refugee policy document **has** also led to different yardsticks for the refugee community in India. While there was a rehabilitation policy in 2014 for about 63,000 Tibetan refugees, there is no such document for the nearly 90,000 Sri Lankan Tamils. At the end of June 2023, the population of refugees or persons of concern in India was over 2.11 lakh (also counting those from Myanmar, Afghanistan, Bangladesh, Africa and West Asia). Any undocumented or overstaying refugee is regarded as an illegal migrant (Citizenship Act). He can also be called an infiltrator. Thus, genuine and harmless refugees risk facing harassment.

Even though the Citizenship (Amendment) Act, 2019 was aimed at providing citizenship to six religious minorities belonging to Bangladesh, Pakistan and Afghanistan, it **drew sharp criticism** as it discriminated **on the lines of** religion and left out sections of Muslims, and also Sri Lankan Tamils and the Rohingya, both minorities in their countries. But in a notification last month, **undocumented or overstaying Tamil refugees**, who have registered themselves with the authorities, **were granted exemption** from **penal** provisions of the Immigration and Foreigners Act, provided they took shelter in India on or before January 9, 2015. Other groups too have been covered. Still, there is no change when it comes to the recent trend of religion-based exclusions. There is nothing fundamentally wrong with the approach of **discreet humanitarian** relief to refugees **in general** but this has to be **backed** by **consistent**, **rational** and fair treatment for all.

Summary of the Editorial

- 1. Union Home Minister Amit Shah emphasized the importance of distinguishing between refugees and infiltrators.
- 2. However, the real issue lies in how the authorities apply these distinctions in practice.
- 3. India lacks a comprehensive refugee policy or a single law defining who qualifies as a refugee.
- 4. The country is not a signatory to the 1951 UN Refugee Convention or the 1967 Protocol.
- 5. Till March 2025, India relied on older laws like the Foreigners Act (1946), Registration of Foreigners Act (1939), and Passport (Entry into India) Act (1920).
- 6. From April 2025, these laws were replaced by the Immigration and Foreigners Act, which streamlined the legal framework.
- 7. Despite this reform, the absence of a formal refugee policy leads to inconsistent treatment of different refugee groups.
- 8. For example, there was a rehabilitation policy (2014) for 63,000 Tibetan refugees, but none for about 90,000 Sri Lankan Tamil refugees.
- 9. As of June 2023, India hosted over 2.11 lakh refugees, including people from Myanmar, Afghanistan, Bangladesh, Africa, and West Asia.
- 10. Under the Citizenship Act, any undocumented or overstaying refugee is considered an illegal migrant and may be labelled an infiltrator.
- 11. This creates a risk that genuine refugees may face harassment or penal action.
- 12. The Citizenship (Amendment) Act, 2019 (CAA) aimed to grant citizenship to six religious minorities from Bangladesh, Pakistan, and Afghanistan.
- 13. The CAA was criticized for being discriminatory, as it excluded Muslims, Sri Lankan Tamils, and Rohingya refugees.
- 14. A recent notification provided exemption from penal action to undocumented Tamil refugees who arrived before January 9, 2015.

Explanations

- 1. However, it immediately follows this by stating that "there is no change when it comes to the recent trend of religion-based exclusions," and concludes that the current approach is one of "discreet humanitarian relief" that lacks consistency. Therefore, the Tamil exemption is an instance of this ad hoc, discreet approach rather than a sign of a fundamental policy shift towards fairness for all.
- 3. A) The passage clearly states that "any undocumented or overstaying refugee is regarded as an illegal migrant" under the Citizenship Act and "can also be called an infiltrator." The Rohingya from Myanmar are specifically mentioned as a group left out of protective laws like the CAA.
- 4. D) The passage presents the exemption for Tamil refugees as a positive example of "discreet humanitarian relief." However, it uses this very example to contrast it with the ongoing "religion-based exclusions" and the lack of a consistent policy. The author's point is that while such specific relief is good, it is not a substitute for a "consistent, rational and fair treatment for all." The other options are contradicted by the passage, which states that discrimination persists and the CAA is criticized for being exclusionary.
- 5. B) The passage opens by agreeing with the need for the distinction but immediately points out that "the problem lies in the application of objective parameters by those in power." It then elaborates on the lack of a single refugee law and a comprehensive policy document, which leads to "different yardsticks" and the risk that "genuine and harmless refugees risk facing harassment." Option A is incorrect because several laws exist. Option C is too absolute and false, as the CAA and specific exemptions prove. Option D is also incorrect, as the passage details different treatments for different groups.

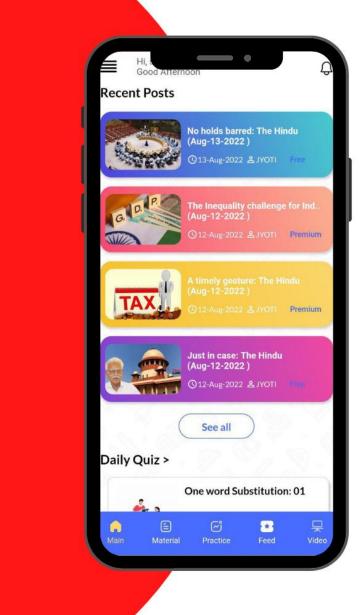

C) 'Majestic' का use होगा क्योंकि "majestic" का अर्थ होता है भव्य, शानदार, या प्रभावशाली। वाक्य में "banks of the majestic river Seine" का उपयोग यह दर्शाने के लिए किया गया है कि Seine नदी अपनी सुंदरता और भव्यता के लिए जानी जाती है, जो पेरिस में होने वाले ओलंपिक का वातावरण और भी आकर्षक बनाती है। जबिक 'Empathetic' का अर्थ है सहानुभूति रखने वाला, जो नदी के संदर्भ में अप्रासंगिक है। 'Armistice' का अर्थ है युद्धविराम, जो यहाँ नदी का वर्णन करने के लिए उपयुक्त नहीं है। 'Gigantic' का अर्थ है विशाल, जो नदी की भव्यता और ऐतिहासिक महत्व को पूरी तरह व्यक्त नहीं करता।
 - 'Majestic' will be used because it means grand, magnificent, or impressive. The phrase
 "banks of the majestic river Seine" highlights the elegance and grandeur of the river,
 enhancing the context of the Paris Olympics. On the other hand, 'Empathetic' means
 showing sympathy, which is irrelevant to describing a river. 'Armistice' means truce,
 which does not fit here. 'Gigantic' only describes enormous size, failing to capture the
 river's elegance and historical significance.
- 23. C) 'Is' का use होगा क्योंकि sentence present tense में है और यह बताता है कि सरकार अभी भी खेलों में पदकों की संख्या बढ़ाने को लेकर आशान्वित है। 'Is' यहाँ सरकार (government) के लिए सही singular verb है। 'Are' plural के लिए use होता है, जो singular subject 'government' के साथ मेल नहीं खाता। 'Was' भूतकाल (past tense) का उपयोग करता है, जो वर्तमान में सरकार की आशावादिता को नहीं दर्शा सकता। 'Were' plural और past tense दोनों के लिए use होता है, जो यहाँ गलत है।
 - 'Is' will be used because the sentence is in the present tense and describes the government's current optimism about winning medals. 'Is' is the correct singular verb for the singular subject 'government.' 'Are' is used for plural subjects, which does not align with the singular subject 'government. 'Was' is past tense and cannot convey the government's ongoing optimism. 'Were' is for plural subjects or hypothetical past situations, which is inappropriate here.
- 24. D) 'Bolster' का use होगा क्योंकि "bolster" का अर्थ होता है किसी चीज़ को मज़बूत करना या समर्थन देना। sentence में नीरज चोपड़ा को अपनी "legendary status" को मज़बूत करने के लिए अपनी श्रेष्ठता साबित करनी होगी। "Bolster" यहाँ सही विकल्प है क्योंकि यह उनके प्रदर्शन को और अधिक मजबूती देने के भाव को दर्शाता है। जबकि 'Resolve' का अर्थ है समस्या का समाधान या दढ़ता दिखाना, 'Cater' का अर्थ है सेवा प्रदान करना, और 'Deter' का अर्थ है रोकना या हतोत्साहित करना।
 - 'Bolster' will be used because it means to strengthen or support something. In the sentence, Neeraj Chopra needs to reinforce his legendary status by performing at his

peak and overcoming elite competitors. 'Bolster' fits perfectly as it signifies adding strength. On the other hand, 'Resolve' means to solve or show determination, 'Cater' means to provide a service, and 'Deter' means to discourage or prevent.

- 25. A) 'Unprecedented' का use होगा क्योंकि "unprecedented" का अर्थ है "अभूतपूर्व", यानी पहले कभी ऐसा नहीं हुआ। पी.वी. सिंधु के पास पहले ही दो ओलंपिक पदक हैं, और अगर वह तीसरा पदक जीतती हैं, तो यह भारत की ओर से किसी महिला खिलाड़ी के लिए एक अभूतपूर्व उपलब्धि होगी। इसीलिए 'unprecedented' यहाँ सबसे उपयुक्त शब्द है। जबिक 'Obligated' का अर्थ है बाध्य होना, 'Excited' का अर्थ है उत्साहित होना, और 'Assorted' का अर्थ है विविध प्रकार का होना, ये शब्द इस संदर्भ में फिट नहीं बैठते।
 - 'Unprecedented' will be used because it means something that has never happened before. P.V. Sindhu already has two Olympic medals, and winning a third would be an extraordinary feat never achieved by any other Indian woman athlete, making 'unprecedented' the right choice. Meanwhile, 'Obligated' means compelled, 'Excited' means feeling eager or enthusiastic, and 'Assorted' means of various kinds. These do not fit the context of describing a never-before-seen accomplishment.
