# Synthetic media: On labelling of AI-generated content

The requirement of labelling Al-generated imagery is a good start

Artificial Intelligence (AI)-generated deepfakes, or synthetically generated images and videos, have been proliferating on social media ever since generative AI made photorealistic content as easy as typing a description of a given scene. As this technology developed rapidly over 2024, concerns were raised over electoral integrity and disinformation amplified with the aid of such AI-generated content. While those concerns did not reach the peaks of the feared outcomes, AI "slop" has become pervasive, from low-budget advertisements to high-budget political caricatures. In this context, the Union government's move to propose mandatory labelling of AI-generated content with an amendment to the IT Rules, 2021, advances the global conversation somewhat in navigating this phenomenon. It is unclear how big the problem of being unable to identify AI slop is for Internet users in India — also the world's second largest AI user base. Two key factors tilt the scales in favour of acting: as with pre-AI disinformation and misinformation, lies and misleading content may at any time explode into virality, granting them a disproportionate place in the democratic setup; and the technology to create photorealistic content that deceives many people is improving every week. Public personalities have frequently complained, sometimes in court, of the usurpation of their likenesses in the service of unscrupulous projects.

Unlike mandatory smoking warnings at the cinema and on OTT streaming services, an intervention that had little industry buy-in before being imposed on entertainment producers and consumers alike with nothing to reliably show for impact, labelling has been offered up by large social media and Al firms from the very beginning of synthetic content's increasing accessibility. Meta, Inc. decided last year to label Al-generated content on Facebook, while the Coalition for Content Provenance and Authenticity (C2PA) has brought industry players together for working on "digital provenance" issues, borrowing a concept from the art appraisal world. Subordinate legislation may not have been the ideal instrument to effect this change — the IT Rules already regulate streaming services, social media content removals and the now-prohibited real money gaming industry, all without being tested in Parliament. At some point, these rules need to be explicitly considered by people's representatives. Technology policymakers have mused throughout the Internet-era that regulation lags behind innovation. The government must be willing to dynamically follow up this proposal with agile action both in terms of relaxing rules that have outlived their utility, and introducing new ones according to requirement.

# **Summary of the Editorial**

- 1. The editorial discusses the rise of AI-generated deepfakes and synthetic media, which have become common on social media platforms.
- 2. With generative AI now able to create photorealistic images and videos from text prompts, misinformation risks have increased.
- 3. During 2024, global concerns grew over Al's impact on elections, fake news, and disinformation.
- 4. Though major disasters were avoided, AI "slop" low-quality or misleading AI-generated content has become widespread in ads and political caricatures.
- 5. To counter this, the Union government of India has proposed mandatory labelling of Algenerated content through amendments to the IT Rules, 2021.
- 6. This move positions India within the global conversation on responsible AI use and regulation.
- 7. The editorial notes that India is the world's second-largest AI user base, making it an important player in this debate.
- 8. Two reasons justify immediate action:
  - Misinformation can go viral quickly, harming democracy.

# **Explanations**

1. A) Mandatory labelling of synthetic media has unusually strong alignment with major platforms compared to past warning mandates.

The passage contrasts labelling with earlier smoking warnings, noting that big social/AI firms (e.g., Meta, C2PA participants) had already offered labelling. That indicates atypically strong industry buy-in compared to past mandates.

- B: The passage says feared outcomes did not reach peaks; harm isn't stated as surpassing forecasts.
- C: It says these rules operate without being tested in Parliament, so not extensively debated/approved.
- D: It states the opposite—regulation lags behind innovation, not outpaces it

### 2. B) instrument

The passage uses "ideal instrument," a standard policy collocation meaning the most suitable means/tool for achieving a change.

- conduit: Means channel/passage; less precise for policy means.
- precedent: Refers to a prior example; not a tool to effect change.
- mandate: Means authoritative command; not the neutral means/tool sense conveyed by "instrument."

### 3. D) Adjective

'Pervasive' describes the noun 'Al slop' by expressing a quality (that it spreads widely), hence it functions as an adjective.

- Noun incorrect, because 'pervasive' does not name a person, place, or thing.
- Verb incorrect, because it doesn't show action.
- Adverb incorrect, because it doesn't modify a verb, adjective, or another adverb.
- 4. B) The regulation of AI content in India is still evolving and may require legislative attention. The passage mentions that "Subordinate legislation may not have been the ideal instrument to effect this change... At some point, these rules need to be explicitly considered by people's representatives." → showing that regulation is still developing.
  - Incorrect the passage says "labelling has been offered up by large social media and Al firms" → so it was supported, not opposed.
  - Incorrect it says "concerns did not reach the peaks of the feared outcomes" → meaning no severe crises occurred.
  - Incorrect the proposal is new and hasn't eliminated misuse; the passage only mentions proposals and initiatives, not success.

### 5. B) Analytical and cautiously optimistic

The writer analyzes the issue of Al-generated content regulation objectively and shows cautious optimism toward the government's proposal, saying it "advances the global conversation somewhat in navigating this phenomenon" while still noting limitations.

• Incorrect — the tone isn't sarcastic; it's serious and reasoned.

- Incorrect though critical in parts, it's not emotional; it's evidence-based.
- Incorrect not neutral or indifferent, since the author clearly evaluates and supports dynamic regulation.

### 7. D) Q, P, S, R

This creates a complete subject phrase: "The cessation of Israel-Iran hostilities, announced by United States President Donald Trump."

P follows Q as it introduces the main verb phrase "sets the stage," which acts on the subject established in Q. This forms the core action: "[The cessation] sets the stage for the denouement of the horror drama."

S follows P as the relative clause "that began on October 7, 2023" directly modifies the noun "horror drama" from P. It adds essential temporal context to the drama.

- R concludes the sentence with the prepositional phrase "with Hamas launching its Operation Toofan al-Aqsa," which grammatically connects to S as an adverbial modifier explaining how the horror drama began.

     only "more than" appropriately expresses that comparative meaning.

### 19. C) **DBAC**

R: Fixed starting point introducing Freud's idea about humans avoiding thoughts of mortality. D: "D" follows "R" because the adverb "therefore" directly links Freud's observation (humans believe they are immortal) to the consequence (discussing death is seen as taboo/grim). B: "B" follows "D" because it introduces a contrasting action ("espousing") in response to the grim reality mentioned in D. "Ever since technology..." sets a new temporal context explaining why the action ("espousing") began.

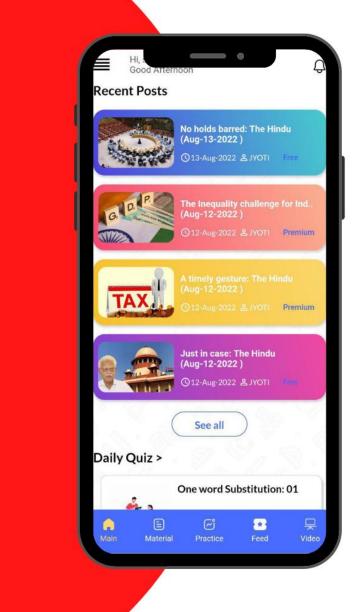
A: "A" follows "B" because it provides justification using the phrase "In keeping with...", linking the advocacy in B (good death) to an external authority (Supreme Court). The noun phrase "attention to quality of death" in A refers back to "good death" in B, reinforcing its importance. C: "C" follows "A" because it defines and elaborates on the concept introduced in B and referenced in A ("good death" and "dignity"). In Hindi:

- R paragraph की fixed शुरुआत है, जो subject "Sigmund Freud" और verb "had remarked" को introduce करता है, यह बताते हुए कि humans को अपनी immortality पर विश्वास है।
- R के बाद D आता है क्योंकि adverb "therefore" R के विचार (immortality belief) का सीधा परिणाम (discussing death is macabre) show करता है। यह एक logical consequence है, जो grammatical connection बनाता है।
- D के बाद B आता है क्योंकि temporal phrase "Ever since technology..." D की समस्या (death discussion is grim) के संदर्भ में speaker के action ("I have been espousing") को introduce करता है।

- A (CADB): Starts with C (definition without context) after R, breaking logical flow.
- B (CDBA): Begins with C after R, but "good death" has no prior introduction.
- D (BCAD): Starts with B after R, missing the consequence "therefore" from D.
- 20. B) 'their' के बदले 'his or her' का प्रयोग होगा क्योंकि 'every actor' एक Singular Noun है और उसके लिए Singular Pronoun प्रयोग होना चाहिए; जैसे—Every student must bring his or her ID card.
  - 'his or her' should be used instead of 'their' because the antecedent 'every actor' is singular, so the pronoun must also be singular; Like—Every student must bring his or her ID card.
- 21. C) **Stands at'** का use होगा क्योंकि यह present tense में है और वर्तमान स्थिति (inflection point) को दर्शाता है। 'Stood at' past tense है, जो context के अनुसार सही नहीं है। 'Step up' और 'set up' का अर्थ क्रमशः 'बढाना' और 'स्थापित करना' है, जो यहाँ fit नहीं होते।
  - 'Stands at' will be used because it is in the present tense and indicates the current position (inflection point). 'Stood at' is in the past tense, which doesn't fit the context. 'Step up' (to increase) and 'set up' (to establish) are irrelevant here.
- 22. B) **Persist'** का use होगा क्योंकि "persist" का अर्थ होता है किसी चीज़ का बने रहना या जारी रहना। Sentence में mention किया गया है कि systemic frictions (तंत्रिक घर्षण) अभी भी बने हुए हैं, इसलिए 'persist' यहाँ सही है। जबिक 'Dissipate' का अर्थ है धीरे-धीरे गायब होना, 'Oscillate' का अर्थ है दोलन करना, और 'Convalesce' का अर्थ है स्वास्थ्य लाभ करना, जो इस context में सही नहीं है।
  - 'Persist' will be used because it means to continue to exist. The sentence mentions that systemic frictions still remain, making 'persist' the correct choice. Whereas, 'Dissipate' means to gradually disappear, 'Oscillate' means to swing back and forth, and 'Convalesce' means to recover from illness, which do not fit in this context.
- 23. A) 'Deter' का use होगा क्योंकि "deter" का अर्थ होता है रोकना या हतोत्साहित करना। sentence में mention किया गया है कि ये friction (रुकावटें) निवेशकों को हतोत्साहित करती हैं और बचत करने वालों को रोकती हैं, इसलिए 'deter' यहाँ सही है। जबकि 'Galvanize' का अर्थ है प्रेरित करना, 'Complain' का अर्थ है शिकायत करना, और 'Incite' का अर्थ है उकसाना, जो इस context में सही नहीं है।
  - 'Deter' will be used because it means to discourage or prevent. The sentence mentions that these frictions are barriers that discourage savers and investors, making 'deter' the correct choice. Whereas, 'Galvanize' means to motivate, 'Complain' means to express dissatisfaction, and 'Incite' means to provoke, which do not fit in this context.
- 24. C)'Deeper' का use होगा क्योंकि यह comparative degree में है और यहाँ structural corrections की अधिक गहराई (greater depth) की आवश्यकता को दर्शाता है। यह वाक्य के context के अनुसार सही है क्योंकि यह मौजूदा सुधारों से आगे की मांग करता है। 'Deepest' (superlative

degree) गलत है क्योंकि यहाँ comparison है, न कि सर्वोच्च स्तर की बात। 'Deep' (positive degree) भी गलत है क्योंकि यह तुलना नहीं दिखाता। 'Deepen' (verb form) यहाँ grammatically fit नहीं होता क्योंकि adjective की आवश्यकता है।

- 'Deeper' will be used because it is in the comparative degree, indicating a need for
  greater depth in structural corrections. It fits the context as the sentence demands
  going beyond existing reforms. 'Deepest' (superlative) is incorrect as it implies the
  highest level, not a comparison. 'Deep' (positive degree) is also incorrect as it lacks
  comparison. 'Deepen' (verb) is grammatically unfit here as an adjective is required.
- 25. A) 'of' का use होगा क्योंकि preposition 'of' यहाँ possession (संबंध) दिखाता है, जो "the growing menace" और "shadow banking" के बीच का संबंध बताता है। यह grammatically सही है क्योंकि 'menace' (खतरा) के बाद 'of' आता है जब हम उसके स्रोत को refer करते हैं। अन्य options जैसे 'to', 'on', और 'at' इस context में सही नहीं हैं क्योंकि वे यहाँ meaningful संबंध नहीं बनाते।
  - 'of' will be used because the preposition 'of' shows possession (relation) between "the growing menace" and "shadow banking." It is grammatically correct because 'of' follows 'menace' when referring to its source. Other options like 'to', 'on', and 'at' are incorrect here as they do not form a meaningful relationship in this context.
