# Hands-off approach: On the Rashtriya Vigyan Puraskar awards

Scientists are the best judges of **excellence** in science

The government has announced a list of 24 individual scientists and a team as **recipients** of the second edition of the Rashtriya Vigyan Puraskar (RVP) awards, **conferred** by the Centre for scientific achievement. As in 2024, this year too has four broad categories: the Vigyan Ratna, Vigyan Shri, Vigyan Yuva-Shanti Swarup Bhatnagar award and Vigyan team award. The Vigyan Ratna and Vigyan Shri are for scientists who have made **distinguished** contributions over their lifetime, and recent distinguished contributions respectively. The Yuva is for individuals under 45 and the final one for a team **endeavour** in technology development.

In theory, the total number of awards, under all categories, is capped at 56; though this year, there are fewer than the 33 awarded last year. The award announcement has been delayed by several months, but this could indicate greater scrutiny of potential awardees. It is important to note that unlike earlier editions of national science awards, for instance the Shanti Swarup Bhatnagar (SSB) awards, there is no cash component given for the RVP, to align with the spirit of the Padma awards. But scrutiny is a double-edged sword. Last year, it emerged that some scientists were told about being recipients, only to be informed later that their names had been dropped. Several prominent scientists across India wrote to the Office of the Principal Scientific Adviser (PSA), demanding transparency in the process of award selection. There were concerns that factors other than scientific merit — for instance, criticism of government policy and political **ideology** — may have played a role. The PSA has not categorically responded to these demands except to point out that the selection committee, called the Rashtriya Vigyan Puraskar Committee (chaired by the PSA and which includes Secretaries of Ministries and members of scientific academies), "recommended" awardees to the Minister of Science and Technology. It is not explicit whether the Minister can overturn a recommendation made by the committee. The RVP awards were instituted after the Ministry of Home Affairs and heads of science departments concluded in 2022 that there were too many awards being given out by individual scientific departments and, hence, necessary to trim them and raise their 'stature' to national awards. While awards such as the SSB awards too were finalised in consultation with the Science Minister, the centralisation and the explicit attempt to make the RVP 'Padma-like', means that they appear far more politicised than they ought to be. If the aim of the RVP is to increase 'stature', the government must be seen to have an explicitly hands-off approach and let scientists judge the excellence of their **peers**. [Practice Exercise]

# **Summary of the Editorial**

- 1. The government has announced 24 winners for the second edition of the Rashtriya Vigyan Puraskar (RVP).
- 2. The awards have four categories: Vigyan Ratna, Vigyan Shri, Vigyan Yuva-Shanti Swarup Bhatnagar, and Vigyan Team award.
- 3. These categories recognize lifetime achievement, recent contributions, scientists under 45, and team efforts, respectively.
- 4. The total number of awards is capped at 56, but this year's count (24) is lower than last year's (33).
- 5. The delay in announcement might indicate greater scrutiny of potential awardees.
- 6. Unlike previous science awards, the RVP has no cash prize, aligning it with the Padma awards.
- 7. However, the scrutiny process has been problematic and lacks transparency.
- 8. Last year, some selected scientists were later dropped without clear explanation.
- 9. Many prominent scientists have written to the government demanding transparency in the selection process.
- 10. There are concerns that non-scientific factors, like criticism of government policy, may influence selections.
- 11. The selection committee (RVPC) is chaired by the Principal Scientific Adviser and includes government secretaries and academy members.

# **Explanation**

## 1. B) The need for depoliticization and transparency in science awards

The passage's central idea revolves around how the Rashtriya Vigyan Puraskar awards system has become overly centralised and potentially politicised. The author stresses that the government should adopt a "hands-off approach" and allow scientists to evaluate their peers objectively — emphasizing transparency, fairness, and autonomy.

- The government's success in promoting scientific excellence: Incorrect because the passage questions, rather than praises, the government's handling of awards.
- The decline of scientific research in India: Incorrect since the passage focuses on the award process, not on research quality.
- The role of young scientists in national development: Incorrect because young scientists are mentioned only as one award category, not the main focus.

## 2. D) The Principal Scientific Adviser (PSA)

The passage clearly states that "the Rashtriya Vigyan Puraskar Committee (chaired by the PSA and which includes Secretaries of Ministries and members of scientific academies)" — confirming that the PSA is the chairperson.

- Minister of Science and Technology He receives recommendations, not chairmanship.
- President of India Has no role in the RVP committee.
- Secretary of the Ministry of Home Affairs Mentioned as part of earlier decisions, not this committee.

### 3. C) To consolidate numerous departmental awards into national-level recognition

The passage mentions that the RVP awards were created because "there were too many awards being given out by individual scientific departments and, hence, necessary to trim them and raise their 'stature' to national awards."

- Wrong RVP has no cash component.

'Exempt' means to free someone from an obligation or responsibility, which doesn't align with the context as the sentence discusses participating in activities, not avoiding them. 'Evaluate' means to assess or judge something, which is irrelevant because the sentence focuses on engaging in leisure activities, not assessing them.'Encourage' means to motivate or inspire, but the sentence does not imply motivating others to participate in leisure activities.

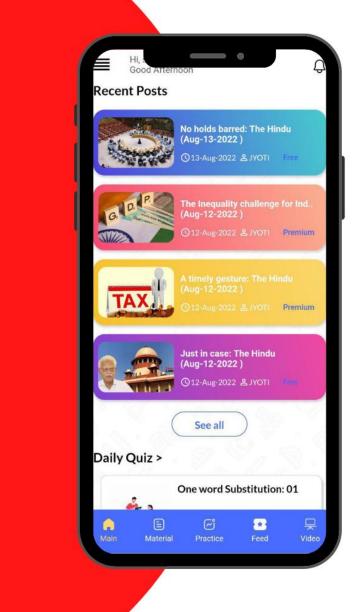
- 'Exoneration' will be used because it means to free someone from blame or declare them not guilty. The passage mentions that the Bombay High Court freed all those convicted in the 2006 Mumbai train blast case, which came as a shock to the victims' families. Hence, 'exoneration' fits here. Whereas, 'condemnation' means strong disapproval, 'inculpation' means blaming, and 'incrimination' means accusing—none of which fit in this context.
- 22. B) **'Has'** का use होगा क्योंकि यहाँ subject "The Bombay High Court's acquittal" singular है और present perfect tense में singular subject के साथ 'has' का प्रयोग होता है। sentence में action (acquittal) का present पर effect दिखाया गया है, इसलिए 'has' सही है। जबकि 'have' plural subjects के साथ use होता है, 'was' past continuous tense में use होता है, और 'were' plural past tense में, जो यहाँ context के अनुसार सही नहीं हैं।
  - 'Has' will be used because the subject "The Bombay High Court's acquittal" is singular, and in present perfect tense, singular subjects take 'has'. The sentence shows the present effect of the action (acquittal), so 'has' is correct. Whereas, 'have' is used with plural subjects, 'was' is used in past continuous tense, and 'were' in plural past tense, which are incorrect here as per the context.
- 23. C) 'Ripped apart' का use होगा क्योंकि इसका अर्थ होता है किसी चीज़ को पूरी तरह से खंडित कर देना। यहाँ sentence में High Court ने investigation को पूरी तरह से खारिज कर दिया है, जिसमें witnesses को untrustworthy बताया गया है, confessions को दबाव में लिया हुआ कहा गया है, और forensic evidence को unreliable बताया गया है। इसलिए 'ripped apart' यहाँ सही है। जबिक 'kept out' का अर्थ है बाहर रखना, 'take advantage of' का अर्थ है फायदा उठाना, और 'drove up' का अर्थ है बढ़ाना, जो इस context में सही नहीं है।
  - 'Ripped apart' will be used because it means to completely dismantle or criticize severely. Here, the sentence states that the High Court has severely criticized the investigation, calling witnesses untrustworthy, confessions coerced, and forensic evidence unreliable. Thus, 'ripped apart' fits perfectly. Whereas, 'kept out' means to exclude, 'take advantage of' means to exploit, and 'drove up' means to increase, none of which fit in this context.
- 24. B) 'Citing' का use होगा क्योंकि "citing" का अर्थ होता है किसी साक्ष्य या उदाहरण का हवाला देना। यहाँ sentence में forensic evidence (अपराधिक साक्ष्य) का हवाला दिया जा रहा है, इसलिए 'citing' सही है। जबिक 'sighting' का अर्थ है देखना (जैसे किसी वस्तु को), 'site' का अर्थ है स्थान, और 'sighing' का अर्थ है आह भरना, जो इस context में सही नहीं है।
  - 'Citing' will be used because it means to refer to evidence or an example. Here, the sentence is referring to forensic evidence, making 'citing' the correct choice. Whereas, 'sighting' means seeing (e.g., an object), 'site' means a location, and 'sighing' means exhaling audibly, which do not fit in this context.

D) **Sentenced'** का use होगा क्योंकि "sentenced" का अर्थ होता है किसी को सजा सुनाना। इस sentence में mention किया गया है कि 2015 में trial court ने पाँच accused को मौत की सजा और सात को उम्रकैद की सजा सुनाई थी, इसलिए 'sentenced' यहाँ सही है। जबकि 'Precise' का अर्थ है सटीक, 'Briefed' का अर्थ है संक्षिप्त जानकारी देना, और 'Phrased' का अर्थ है शब्दों में व्यक्त करना, जो इस context में सही नहीं है।
  - 'Sentenced' will be used because it means to officially declare punishment for a crime. The sentence mentions that in 2015, the trial court sentenced five accused to death and seven to life imprisonment, making 'sentenced' correct here. Whereas, 'Precise' means exact, 'Briefed' means to give summarized information, and 'Phrased' means to express in words, which do not fit in this context.
