# Meaningless truce: On Netanyahu, the Gaza ceasefire

Netanyahu is making a mockery of the ceasefire agreement

When the **U.S.-brokered** ceasefire **took effect** in Gaza on October 10, 2025, **a big question** that **loomed** over all parties was whether Israeli Prime Minister Benjamin Netanyahu, who accepted the truce under pressure from U.S. President Donald Trump, **would honour** his **commitments** once the **hostages** were released. **Barely** three weeks later, **Mr. Netanyahu**, who had **vowed** to destroy Hamas, **found** a **convenient pretext** to resume **strikes**. He <u>accused Hamas of</u> **violating** the ceasefire, and **claimed** that the remains returned by the group were the body parts of a hostage already **retrieved**. Several hostages are believed to have been **buried** under the **rubble**, while Gaza's officials and Egyptian **excavators** continue struggling to locate and identify bodies of **captives**. On Tuesday, Israel said militants fired anti-tank missiles at soldiers in Rafah, southern Gaza, killing one soldier — Hamas has denied any involvement. Mr. Netanyahu ordered **retaliatory** strikes, killing 104 Palestinians overnight, including 46 children and 20 women. After the **assault**, Israel announced that the ceasefire was back **in effect** — but what kind of a ceasefire is Israel observing if it has the freedom to **carry out devastating** attacks on Palestinian civilians?

While the ceasefire offered a **respite** to the Palestinians from daily Israeli **bombardments** and allowed the release of hostages and Palestinian prisoners, the **absence** of any **credible enforcement mechanism makes** it extremely **fragile**. Israeli troops still control roughly 55% of Gaza's territory. It would be unrealistic to expect that the **Palestinians**, who were **bombed** and **displaced** repeatedly over 24 months, **would** quietly accept the Israeli military **occupation**. Hamas has **enforced** its control in the rest of Gaza. Within Israel, Mr. Netanyahu's far-right **coalition** allies want the war to continue and Gaza **ethnically cleansed** of Palestinians. Despite the deep mistrust, all sides agreed to the ceasefire largely under U.S. pressure — Hamas needed a reprieve and Israel wanted its hostages back. **The next stage** of Mr. Trump's peace plan **is** even more controversial as it calls for Hamas's **disarmament**, which it has not agreed to. If Mr. Trump is serious about the peace push, he must own his plan and build mechanisms that ensure both sides **adhere to** their commitments. His **boastful** talk about peace will mean little if he allows Israel to continue to kill Palestinian civilians with **impunity**, while claiming that the ceasefire remains **in place**. For any truce to **endure**, Israeli troops must withdraw from Gaza and a new Palestinian administration should be in charge of the **enclave**. What Palestinians in Gaza **desperately** need is assistance for recovery, **resettlement** and reconstruction — not more bombs.

## **Summary of the Editorial**

- 1. The U.S.-brokered ceasefire in Gaza took effect on October 10, 2025, after intense pressure from U.S. President Donald Trump on Israeli Prime Minister Benjamin Netanyahu.
- 2. A major concern was whether Netanyahu would respect the ceasefire once Israeli hostages were released.
- 3. Within three weeks, Netanyahu resumed strikes on Gaza, accusing Hamas of violating the ceasefire.
- 4. Israel claimed that the remains Hamas returned were body parts of a hostage already recovered earlier.
- 5. Many hostages remain missing, possibly buried under the rubble, with Palestinian and Egyptian rescuers still searching.
- 6. Israel reported that militants fired anti-tank missiles in Rafah, killing one soldier, but Hamas denied involvement.
- 7. Netanyahu ordered retaliatory airstrikes, which killed 104 Palestinians, including 46 children and 20 women.
- 8. After the deadly assault, Israel declared the ceasefire was back, raising doubts about the credibility of such a truce.
- The ceasefire, though a temporary relief, lacks any credible enforcement mechanism, making it fragile.
- 10. Israeli troops still occupy 55% of Gaza, making it unrealistic for Palestinians to accept continued military control.
- 11. Hamas controls the remaining areas of Gaza, deepening the territorial division and mistrust.

## **Explanations**

1. A) It is effectively unenforceable, letting Israel strike while still claiming a truce.

The author stresses the lack of an enforcement mechanism and questions "what kind of a ceasefire" it is if Israel can conduct devastating attacks while the truce is "in effect."

- B: The passage highlights deep mistrust and says U.S. pressure, not trust, pushed parties to accept the truce.
- C: It explicitly states Hamas has not agreed to disarm.
- D: Israel still controls roughly 55% of Gaza, so it has not relinquished most control.
- 2. A) Netanyahu ordered strikes that killed 104 Palestinians, including 46 children and 20 women; afterward, Israel said the ceasefire was back in effect.

Matches the passage after the Rafah incident (which Hamas denied), Netanyahu ordered retaliatory strikes killing 104, including 46 children and 20 women; after the assault, Israel announced the ceasefire was back "in effect."

- B: Numbers are wrong (55 vs 104) and the passage does not say U.S. pressure restored the ceasefire "within hours."
- C: Hamas denied involvement; also there were devastating strikes with heavy civilian deaths reported.
- D: The passage says officials/excavators are struggling to locate and identify remains; it does not say all remains were confirmed, nor that Israel paused operations for that reason.
- 3. B) there is no credible enforcement mechanism to ensure adherence

The passage states that the absence of any credible enforcement mechanism makes the ceasefire extremely fragile.

- A: The passage says Hamas needed a reprieve and agreed to the ceasefire; it does not say they outright rejected releases.
- C: Egyptian excavators are helping; no refusal is mentioned.
- D: No claim of U.N. declaring full demilitarization appears in the passage.
- 4. C) Because Israel resumed strikes while still asserting the ceasefire was in effect

The author notes retaliatory strikes that killed civilians, followed by an announcement that the ceasefire was still in effect—hence questioning the nature of the ceasefire.

- A: The passage says Israeli troops still control roughly 55% (not withdrew).
- B: Hamas has not agreed to disarmament.
- D: Several hostages are believed buried under rubble; full safe release/identification is not claimed.
- 5. C) Adverb

"Ethnically" modifies the implied participle "cleansed" by specifying the manner/type of cleansing; as a -ly form modifying a verb/participle, it functions as an adverb.

A: It does not name a person/place/thing/idea; not a noun.

- B: The adjective form would be "ethnic," but here the -ly form modifies a verbal idea.
- D: It does not show a relationship like "in," "at," "from," etc.; not a preposition.

Stoke' means to fuel or encourage something, not related to food or ordering. 'Stink' means a bad smell, which does not fit the context of the sentence at all.

  - In the passive sentence, "the department" (Object) becomes the subject. The verb is transformed into "has been reorganised" (Present Perfect Passive). Adding "by us" is optional and does not alter the meaning of the sentence.

C) 'Harmony' का use सही है क्योंकि इसका अर्थ होता है शांति, सौहार्द्र या सामंजस्य, जो गांधीजी के जीवन दर्शन के अनुसार एक शांतिपूर्ण और आदर्श समाज के निर्माण का संदर्भ देता है। यहाँ 'peace' (शांति) और 'harmony' एक दूसरे के पूरक हैं। Discord: इसका अर्थ होता है विवाद या असहमति, जो 'peace' के विपरीत है। इस संदर्भ में यह पूरी तरह से अनुचित है। Agitation: इसका अर्थ होता है व्याकुलता या अशांति, जो 'peace' के बिल्कुल विपरीत है। यह शब्द वाक्य की भावनात्मक और संदर्भगत संगति को बिगाड़ देता है।Cacophony: इसका अर्थ होता है कर्णकटु शोर या अव्यवस्थित ध्वनि, जो 'peace' के विपरीत अर्थ रखता है।
  - 'Harmony' is the correct choice because it means a state of peaceful coexistence and agreement, which aligns with the idea of a peaceful and ideal society as described in the sentence. The word "peace" and "harmony" complement each other, making this

option contextually appropriate. Discord: It means disagreement or conflict, which is the opposite of "peace" and does not fit the positive tone of the sentence. Agitation: It refers to unrest or disturbance, which contradicts the concept of "peace" and is inappropriate here. Cacophony: It means a harsh, discordant noise, which again opposes the idea of a peaceful society.

#### 18. C) **SQRP**

S starts with "The application", which refers directly to the application mentioned in S1 (Form X application). This establishes a clear noun connection: the application in S1 requires an attachment (Form V) as stated in S.

Q follows S as it introduces the subject "the licensing officer" (who receives the application) and the verb "may accept", which describes the action taken on the application submitted with Form V. This creates a subject-verb relationship: the licensing officer may accept.

R follows Q as it begins with "The license", which is the object being surrendered, and the verb "shall be deemed" explains the consequence of the acceptance in Q. The phrase "such acceptance" directly refers back to the acceptance in Q.

P follows R as it starts with "This", which refers to the entire surrender process (termination of license in R), and the verb "shall not entitle" states the rule regarding compensation after termination.

Finally, S6 naturally follows P, as it talks about what the licensee is allowed to do after surrender (sell antiquities), which contrasts with no compensation (P). In Hindi:

- S sentence S1 के बाद आता है क्योंकि यह "The application" (जिसका S1 में mention है) के साथ जुड़ने वाले document (Form V) को specify करता है। यह logical sequence बनाता है: apply करने के बाद documents attach करने हैं।
- Q, S के बाद आता है क्योंकि इसमें subject "the licensing officer" introduce होता है, जो application receive करता है, और verb "may accept" बताता है कि officer क्या action लेता है। यह S1 और S में mentioned application process को आगे बढ़ाता है।
- R, Q के बाद naturally fit होता है क्योंकि यह "The license" (main object) को refer करता है और verb "shall be deemed" बताता है कि acceptance (Q में mentioned) की date से license terminate मानी जाएगी। "Such acceptance" directly Q को refer करता है।
- P, R के बाद आता है क्योंकि "This" (यह) surrender और termination (R में described) को collectively refer करता है, और verb "shall not entitle" compensation के rule को बताता है। यह termination के after effect है।
- S6 then P के बाद आता है, क्योंकि यह बताता है कि compensation नहीं मिलेगा, लेकिन antiquities बेचने की allowance है।
- 19. B) 'could be avoided' के बदले 'could have been avoided' का प्रयोग होगा क्योंकि यह एक third conditional sentence है जिसमें past unreal condition दी गई है। इसमें दोनों Clauses में Past Perfect (had + V3) और would/could have + V3 का प्रयोग होता है; जैसे—If he had studied well, he would have passed the exam.
  - 'could have been avoided' will be used instead of 'could be avoided' because this is a third conditional sentence (unreal condition in the past). The correct structure is:

If + had + V3, then would/could have + V3; Like—If he had studied well, he would have passed the exam.

- 20. D) 'Asserted' का use होगा क्योंकि इसका अर्थ है दृढ़ता से कहना या बताना। यहाँ sentence में Minister के द्वारा एक दृढ़ बयान दिए जाने का संकेत है, जिसमें कोई समझौता नहीं होगा। 'Asserted' इस context के लिए सही है। जबिक 'Refuted' (खंडन करना), 'Contradicted' (विरोध करना), और 'Rebutted' (जवाब देना) नकारात्मक अर्थ देते हैं, जो यहाँ fit नहीं होते।
  - 'Asserted' will be used because it means to state firmly or declare. The sentence
    indicates a strong statement by the Minister that there will be no compromise, making
    'asserted' the correct choice. Whereas, 'Refuted' means to deny, 'Contradicted' means
    to oppose, and 'Rebutted' means to counter, which do not fit this positive declaration
    context.
- 21. C) 'Was made' का use होगा क्योंकि यहाँ passive voice की आवश्यकता है। sentence में बताया गया है कि "कोई समझौता नहीं किया गया" (no compromise was made), जो past tense और passive form में सही है। 'Made' (A) और 'make' (D) passive structure में नहीं हैं, जबकि 'makes' (B) present tense में है, जो context के अनुसार गलत है।
  - 'Was made' will be used because the sentence requires passive voice. It indicates that "no compromise was made" in any sensitive sector, which is grammatically correct in past tense and passive form. 'Made' (A) and 'make' (D) are not in passive structure, while 'makes' (B) is in present tense, making it incorrect for this context.
- 22. A) 'Seemed' का use होगा क्योंकि यह past tense में है और context के अनुसार, Minister के द्वारा किए गए कथन या कार्य को दर्शाता है जो पहले ही हो चुका है। यहाँ 'seemed' (प्रतीत हुआ) सही है क्योंकि यह बताता है कि Minister ने संवेदनशील क्षेत्रों को केवल कृषि और श्रम-गहन विनिर्माण तक सीमित रखा प्रतीत हुआ। अन्य विकल्प 'vanished' (गायब हो गया), 'seems' (प्रतीत होता है present tense), और 'faded' (फीका पड़ गया) context के अनुरूप नहीं हैं।
  - 'Seemed' will be used because it is in the past tense and aligns with the context, indicating the Minister's apparent action or statement that has already occurred. Here, 'seemed' (appeared) is correct as it suggests that the Minister appeared to count only agriculture and labour-intensive manufacturing as sensitive sectors. Other options—'vanished' (disappeared), 'seems' (present tense), and 'faded' (lost significance)—do not fit the context grammatically or logically.
- 23. B) 'On' का use होगा क्योंकि "impact on" एक fixed prepositional phrase है जिसका अर्थ होता है "पर प्रभाव"। यहाँ sentence में digital sector पर FTA के प्रभाव की बात हो रही है, इसलिए 'on' सही है। जबिक 'at' (पर), 'for' (के लिए), और 'to' (को) इस context में grammatically incorrect हैं क्योंकि वे "impact" के साथ सही तरीके से नहीं जुड़ते।
  - On' will be used because "impact on" is a fixed prepositional phrase meaning "प्रभाव पड़ना." Here, the sentence talks about the effect of the FTA on the digital sector, making 'on' correct. Whereas, 'at' (at a point), 'for' (purpose), and 'to' (direction) are grammatically incorrect here as they don't collocate properly with "impact."

- 24. A) 'Has gone' का use होगा क्योंकि यह present perfect tense है जो past के action को present से जोड़ता है। यहाँ digital sector के impact के बारे में बात हो रही है जो past में हुआ और अभी तक relevant है, इसलिए 'has gone' सही है। 'Went' (simple past) यहाँ present relevance नहीं दिखाता, 'gone' (past participle) auxiliary verb के बिना अधूरा है, और 'is going' (present continuous) यहाँ context के अनुसार गलत है।
  - Has gone' will be used because it is in the present perfect tense, connecting a past
    action to the present. The sentence discusses the impact on India's digital sector, which
    happened in the past but remains relevant now, making 'has gone' correct. 'Went'
    (simple past) doesn't show present relevance, 'gone' (past participle) is incomplete
    without an auxiliary verb, and 'is going' (present continuous) doesn't fit the context.
- 25. A) **Take over** (phrasal verb) assume charge, take the helm, step in, assume office, take command पदभार সहण কरना

Synonym: **Assume charge** (verb) – Begin responsibility (जिम्मेदारी लेना)

- **Resign** (verb) Quit, leave position (इस्तीफा देना)
- Vacate (verb) Leave empty (खाली) करना)
- **Abdicate** (verb) Renounce, give up power (त्यागना)
