Death on the move: On India's disgraceful record in fatal road accidents

Road accidents are not resulting in overhaul of infrastructure and licensing

The highway accident on November 3, 2025 that claimed 19 lives at Chevella near Hyderabad was far too routine to change India's disgraceful record in fatal road accidents. The driver of a gravel-laden truck apparently swerved to avoid a pothole and rammed into a bus. There were no dividers, no streetlights and no signages on that stretch of National Highway 163. India's roads are a major public hazard. Pedestrians, bus riders and two-wheeler motorists constitute the majority of the over 400 people who die on India's roads on average, the equivalent to a full transcontinental flight going down. Flight disasters invite scrutiny, multi-agency probes and quick remedial actions but road accident deaths that mostly involve poorer folk trigger perfunctory probes and glacial change in rules, if any. Government documents identify human error as the most common cause but deeper reasons — vehicular and infrastructural — are unaddressed.

In India, the road test for getting a driving licence examines whether the person is able to handle a vehicle of certain specification, largely a skill test, rather than one of his knowledge and execution of safe driving practices. No safety training is **mandated**. Most accidents are **collisions** from the back whereas exemplar driving tests in other countries filter out tailgating tendencies and arbitrary lane changing. The system of certifying and monitoring drivers and vehicles is broken and corrupt. For nearly all Indians, navigating RTOs is unpleasant. The SaveLIFE Foundation advocates License Seva Kendras — on the lines of Passport Seva Kendras — so that they are transparent, digitised, and ensure good driver skills and safety awareness. One in five accidents are head-on collisions, which have happened even on four-lane highways, indicating wrong-side driving and the state of road dividers. In general, national highways need to adhere to Indian Roads Congress guidelines but States have made no mandates as required by the Motor Vehicles Act. There are potholes, dangerous curves, drainage systems, bridge parapets and concrete objects, but no crash barriers or energy absorbers. Collision-risk warning devices are relatively inexpensive and can be mandated on commercial vehicles. Better pedestrian infrastructure alone can prevent many fatalities. In Hyderabad, a community health-care centre was available for immediate treatment and a government hospital was not far away. But that is often not the case elsewhere. In States such as Bihar, fatality rates are double because of inadequate trauma care infrastructure. An overhaul of the road transport system is an urgent requirement in India. [Practice Exercise]

Summary of the Editorial

- 1. A tragic highway accident on November 3, 2025, near Chevella (Hyderabad) killed 19 people, exposing once again India's poor road safety conditions.
- 2. The accident occurred when a truck swerved to avoid a pothole and hit a bus, revealing the absence of dividers, streetlights, and signages on National Highway 163.
- 3. India records over 400 road deaths daily, comparable to a plane crash every day, yet such incidents fail to prompt systemic reforms.

Explanations

- 1. B) It focuses primarily on vehicle handling skills rather than safety knowledge.

This highlights the core flaw of emphasizing mechanical control over safe driving practices like avoiding tailgating and arbitrary lane changing.
- 2. A) Flight disasters receive more immediate attention and action than road accidents. The author contrasts the response to the Chevella accident, described as "far too routine," with the response to flight disasters, which "invite scrutiny, multi-agency probes and quick remedial actions." This comparison is used to criticize the "perfunctory probes and glacial change" that follow road accidents, which predominantly affect poorer citizens.
- 3. C) The high cost of fuel leading to poorly maintained vehicles.
 - The passage lists several infrastructural issues, including potholes, dangerous curves, drainage problems, and the lack of crash barriers (as mentioned in the options A and D). It also specifically mentions that fatality rates are higher in states like Bihar due to "inadequate trauma care infrastructure" (option B). However, the cost of fuel and its link to vehicle maintenance is not discussed anywhere in the passage.
- 4. C) Widespread wrong-side driving and substandard road dividers.
 - The passage directly links head-on collisions to two specific factors: "indicating wrong-side driving and the state of road dividers." It explicitly states that these collisions happen even on four-lane highways, which rules out the number of lanes (option A) as the primary cause, and does not mention vehicle mechanics (option B) or police presence (option D) in this context.
- 5. B) Establishing transparent and digitized License Seva Kendras.
 - The passage specifically mentions that "The SaveLIFE Foundation advocates License Seva Kendras on the lines of Passport Seva Kendras so that they are transparent, digitised, and ensure good driver skills and safety awareness." This is a direct proposal to reform the "broken and corrupt" system of certifying drivers. The other options, while mentioned in the passage as other necessary improvements, are not attributed to the SaveLIFE Foundation.

 - B: This sentence naturally follows the previous one (sentence C), as it gives a specific example (INS Mormugao) of the recent developments in the self-reliance program.
 - A: This sentence provides further details about INS Mormugao, which was mentioned in the previous sentence (sentence B). It also follows the Time Sequence rule, providing a specific date when INS Mormugao undertook her first sea sortie.

- D: This sentence provides additional information about INS Mormugao and its indigenisation, thus following sentence A
- 2: The final sentence wraps up the information and talks about the ship's capabilities and importance.

Active से Passive Voice में बदलने के लिए, Active वाक्य का Object Passive वाक्य का Subject बन जाता है। Verb को Active से Passive में बदलते समय सही Tense का प्रयोग किया जाता है। Active वाक्य में "Reena" (Subject), "is attending" (Verb in Present Continuous), और "a seminar online"

(Object) हैं। Passive में बदलने पर Object "The seminar" (Subject) बन गया है, Verb को "is being attended" (Present Continuous Passive) में बदला गया है और "by Reena online" के रूप में प्रयोग किया गया है।

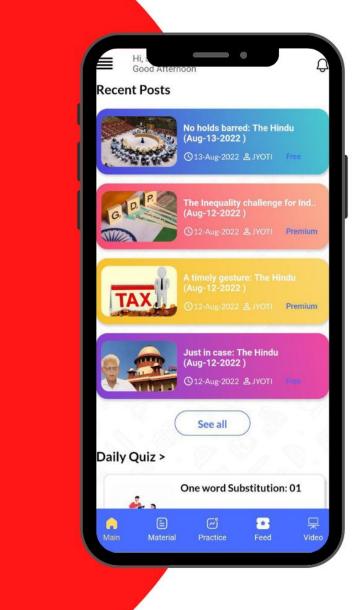
- To change a sentence from Active to Passive Voice, the object of the active sentence becomes the subject of the passive sentence. The verb is transformed from the active form to the passive form, ensuring correct tense usage. In this case, "Reena" (Subject), "is attending" (Verb in Present Continuous), and "a seminar online" (Object) from the active voice have been transformed into "The seminar" (Subject), "is being attended" (Passive Verb in Present Continuous), and "by Reena online".
- 18. B) The incorrectly spelt word is 'Chhivalrous'. The correct spelling is 'Chivalrous' which means "marked by honour, courtesy, and courage; knightly" शौर्यवान
- 19. C) 'absolute' को 'absolutely' में बदला जाएगा क्योंकि 'agree' एक verb है और उसे modify करने के लिए adverb 'absolutely' की आवश्यकता है। जैसे— I absolutely love that movie.
 - 'absolute' should be changed to 'absolutely' because 'agree' is a verb and it requires the adverb 'absolutely' to modify it; Like— I absolutely love that movie.
- 20. B) **To turn over a new leaf** (idiom) To start behaving in a better way एक नई शुरुआत शुरू करना
- 21. B) 'Mobilise' का use होगा क्योंकि वाक्य में infinitive structure "aims to + verb" प्रयोग किया गया है। "Aims to mobilise" (लक्ष्य है जुटाना/प्रेरित करना) grammatically सही है और context में climate-aligned investments को बढ़ावा देने की बात करता है। जबिक 'Mobilises' simple present tense है जो यहाँ infinitive की जगह fit नहीं होता, 'Mobilised' past participle है जो tense structure बिगाड़ देता है, और 'Mobilising' continuous/gerund form है जो सही grammatical construction नहीं देता।
 - 'Mobilise' will be used because the structure is "aims to + base verb". The sentence says the taxonomy aims to mobilise climate-aligned investments, making "mobilise" correct. Whereas 'mobilises' is simple present, 'mobilised' is past, and 'mobilising' is continuous/gerund, none fit grammatically.
- 22. A) '**To'** का use होगा क्योंकि phrase "adaptable to" standard grammatical collocation है, जिसका अर्थ है किसी चीज़ के अनुसार ढलने योग्य होना। Sentence में कहा गया है कि framework adaptable to India's priorities यानी भारत की प्राथमिकताओं के अनुसार ढलने योग्य है। जबकि 'In' का अर्थ होता है के अंदर, 'Of' का अर्थ होता है का/की, और 'At' का अर्थ है पर ये contextually और grammatically fit नहीं होते।
 - 'To' will be used because the correct collocation is "adaptable to", meaning capable of
 adjusting according to something. The sentence highlights that the framework is
 adaptable to India's priorities. Whereas 'in' means inside, 'of' means belonging to, and
 'at' means location none work here.
- 23. D) **Evolving'** का use होगा क्योंकि "evolving" का अर्थ है लगातार बदलता या विकसित होता हुआ। Sentence में "India's evolving priorities" का मतलब है भारत की बदलती हुई प्राथमिकताएँ, और यहाँ noun "priorities" को describe करने के लिए adjective चाहिए। इसलिए 'evolving' सही है। जबकि

'Evolved' का अर्थ है पहले से विकसित हो चुका, जो context में fit नहीं बैठता। 'Evolves' verb form है और noun को directly modify नहीं कर सकता। 'Evolve' भी verb है, इसलिए यहाँ उपयुक्त नहीं है।

- 'Evolving' will be used because it means continuously changing or developing. The sentence requires an adjective: "India's evolving priorities", meaning India's changing priorities. Whereas 'Evolved' means already developed (past), 'Evolves' is a verb form (he evolves/it evolves) and cannot modify a noun, and 'Evolve' is also a verb, so they are incorrect here.
- 24. A) 'Its' का use होगा क्योंकि यहाँ बात "the document" (singular, non-living entity) की हो रही है, और किसी चीज़ के belonging/possession को दिखाने के लिए "its" का प्रयोग किया जाता है। Sentence में मतलब है "however, its success…", यानी उस document की सफलता। जबिक 'Their' plural subject के लिए use होता है, जो यहाँ सही नहीं है। 'His' किसी male person के लिए होता है, और document के लिए उपयुक्त नहीं। 'It's' contraction है "it is" या "it has" का, जो यहाँ grammatically फिट नहीं होता।
 - 'Its' will be used because the subject is "the document," a singular, non-human noun.
 "Its" shows possession (the success of the document). Whereas 'Their' refers to plural subjects, 'His' refers to a male person, and 'It's' means it is/it has, which doesn't fit here.
- 25. D) **Credible'** का use होगा क्योंकि "credible" का अर्थ है भरोसेमंद या विश्वसनीय। sentence में बात की जा रही है कि यह framework एक governance tool के रूप में सफल हो पाएगा या नहीं, और उसके लिए उसे भरोसेमंद होना ज़रूरी है। इसलिए 'credible' यहाँ सही है। जबिक 'Apocryphal' का अर्थ है संदिग्ध या झूठा, 'Ossified' का अर्थ है जड़/कठोर होना, और 'Stultify' का अर्थ है निष्क्रिय या बेअसर करना, जो इस context में सही नहीं है।
 - 'Credible' will be used because it means reliable or trustworthy. The sentence is about the taxonomy's success as a governance tool, and for that, being credible is essential. Whereas 'Apocryphal' means doubtful/false, 'Ossified' means rigid, and 'Stultify' means to render ineffective — none of these fit the context.
