Renewed rivalry: On the India, South Africa first Test, at Eden Gardens

India will be keen to move ahead in the new cricket Test cycle

Kolkata's Eden Gardens, one of cricket's hallowed venues, will again host South Africa. Back in 1991, when South Africa was readmitted to cricket following the withdrawal of apartheid and the consequent lifting of a 21-year sporting ban, it was the eastern metropolis that rolled out the red carpet to Clive Rice and his men. The first ODI was played at a packed Eden on November 10, 1991, one in which India prevailed, and 34 years later, another Protean unit led by Temba Bavuma will clash against Shubman Gill's men in the first Test commencing on Friday (November 14, 2025). In a fresh cycle, South Africa, the defending champion in the ICC World Test Championship, is up against India, often an indomitable force in its own backyard. That the tour of England was drawn at 2-2 in the longest format and the subsequent Tests against the West Indies at home were swept aside, is a pointer to the form and ability of Gill's unit despite the retirements of Virat Kohli, Rohit Sharma and R. Ashwin and the continued absence of Mohammed Shami. The first two may still be playing ODIs, but this truly is Gill's era and five tons in his last seven Tests reveals a batter finding an extra gear when given the extra responsibility of captaincy.

This latest cricketing **joust** is like a full-course meal as it **features** two Tests, three ODIs and five T20Is. India can finesse its plans and team combinations in all three formats, besides gaining further inputs on the form and relevance of Rohit and Kohli after their decent run during the recent ODIs in Australia. The T20Is too will have an added layer as India and Sri Lanka will be hosting the ICC T20 World Cup next year. That Rishabh Pant is back in the mix, after a hiatus following an injury, augurs well while the other wicket-keeper Dhruv Jurel may still find his slot as a pure batter considering his exploits with the India A unit. Gill, Yashasvi Jaiswal, K.L. Rahul, Ravindra Jadeja, Pant, Jasprit Bumrah and Mohammed Siraj constitute the nucleus of a squad that is dealing with transition under coach Gautam Gambhir. South Africa with its blend of doughty batters and a sharp attack headlined by Kagiso Rabada, can be a strong opposition. The visitors also have an adequate blend of spin revealing an Indian origin flavour thanks to the presence of Keshav Maharaj and Senuran Muthusamy. Last year, host India was humbled by New Zealand and even if it is largely seen as an aberration, Bavuma's men could **draw** inspiration from **the Black Caps**. [Practice Exercise]

Explanations

1. B) Analytical

The passage evaluates India—South Africa cricket prospects, compares past performances, discusses players, formats, team combinations, and future tournaments. The writer analyzes the cricketing context with factual assessment.

- Nostalgic: Although it briefly recalls 1991, the dominant tone is evaluation and analysis, not emotional longing.
- Humorous: No jokes, light-hearted remarks, or playful tone appear. The passage is serious and factual.
- Pessimistic: The passage does not express negativity; instead, it highlights strengths, opportunities, and team form.

2. B) Eden Gardens, Kolkata.

The passage says the first ODI after South Africa's readmission was played at a packed Eden Gardens on November 10, 1991.

- A Lord's, London: Not mentioned in the passage; the match described took place in Kolkata.
- C Newlands, Cape Town: Newlands is in South Africa, but the passage specifically names Eden Gardens.
- D Wankhede Stadium, Mumbai: Also not mentioned; the passage names Eden Gardens as the venue.

D) November 10, 1991.

The passage explicitly states the first ODI was played on November 10, 1991.

- A November 14, 2025: This date in the passage refers to the start of the Test (34 years later), not the 1991 ODI.
- B— November 14, 1991: The correct 1991 date given is November 10, not the 14th.
- C— November 10, 1994: The year is wrong; the passage gives 1991 as the year of readmission's first ODI.

4. C) Possessive pronoun

"its" shows ownership/possession of "plans" and "team combinations," so it is a possessive pronoun.

- Relative pronoun Words like who, which, that; "its" is not used to link clauses.
- Reflexive pronoun Would be itself; used when the subject and object are the same.
- Demonstrative pronoun Refers to this, that, these, those; "its" does not indicate pointing or demonstrating.

5. B) That the tour of England was drawn at 2-2 and the subsequent Tests were swept aside, is a pointer to the team's form.

The subject is the entire clause "That the tour... were swept aside", which is singular, so it correctly takes the singular verb "is".

• Incorrect: "The first ODI" is singular, so it should be "was played," not "were played."

- Incorrect: The main subject is "South Africa" (singular team name), so it should be "is a strong opposition."
- Incorrect: With "along with," the verb agrees with the first subject "Gill" (singular). It should be "has been preparing."

6. B) **QRPS**

- Q: Q comes first because it sets the time context "an hour before the fall of the dusk."
- R: R should follow Q since it's the next logical progression. After mentioning the time, the narration moves to describe the action taking place during that time driving back home through the Western Ghats
- P: P comes after R. The first part of P ("Except for too many curves and bends that the driver had to negotiate") provides additional details about the journey mentioned in R.
- S: Sentence S is a fragment or is incorrectly transcribed because "To negotiate, it, otherwise, was a pleasant evening to drive back home" is an incomplete thought and largely redundant when compared to sentence P.
- 7. B) My office colleagues have organised a farewell party for me.

 - To change a sentence from Passive to Active Voice, the object of the passive sentence becomes the subject of the active sentence. The verb is transformed from the passive form to the active form while ensuring correct tense usage. In this sentence, "A farewell party for me" (Subject in Passive), "has been organised" (Verb in Present Perfect Passive), and "by my office colleagues" (Agent) are given. When converting to Active Voice, "My office colleagues" (Subject) comes first, "have organised" (Present Perfect Active) is the verb, and "a farewell party for me" (Object) remains at the end.
- 8. B) 'As a consequence of' का use होगा क्योंकि "as a consequence of" का अर्थ होता है किसी कारण से। Sentence में इसे इस तरह use किया जा रहा है कि किसी कारण से (उसकी बीमारी के चलते) उसने काम समय पर पूरा नहीं किया। इसलिए 'As a consequence of' यहाँ सही है। जबिक 'Subsequent for' का अर्थ होता है बाद में के लिए, 'In consequence to' grammatically सही नहीं है, और 'On account' अधूरा और असंगत है, जो इस context में सही नहीं है।
 - 'As a consequence of' should be used because it means due to a particular reason. The sentence is implying that due to a reason (his illness), he could not complete the work on time. Therefore, 'As a consequence of' is the correct choice here. Whereas, 'Subsequent for' means later for, 'In consequence to' is not grammatically correct, and 'On account' is incomplete and out of context, making them inappropriate for this sentence.

- 9. C) **Concerning'** का use होगा क्योंकि "concerning" का अर्थ होता है 'संबंधित' या 'विषय में'.

 Sentence में mention किया गया है कि उसने संगठन के भविष्य से संबंधित कई प्रश्न उठाए, इसलिए 'concerning' यहाँ सही है। जबिक 'concern to' और 'concerned for' का अर्थ होता है किसी चीज़ के प्रति चिंता, और 'concerned with' का अर्थ है किसी विषय में रुचि रखना, जो इस context में सही नहीं है।
 - 'Concerning' should be used because it means 'related to' or 'about'. The sentence
 mentions that he raised several questions related to the future of the organisation,
 making 'concerning' fitting here. Whereas, 'concern to' and 'concerned for' imply worry
 or care about something, and 'concerned with' means to be interested in a subject,
 which don't fit in this context.
- 10. C) 'were' का प्रयोग गलत है क्योंकि 'five miles' यहां पर संख्या के रूप में प्रयुक्त हुई है और यह सिंगुलर माना जाता है। इसलिए, 'was' का प्रयोग होना चाहिए। जैसे— Five miles is not a long distance.
 - 'were' is used incorrectly because 'five miles' is considered singular when referring to a
 distance. Therefore, 'was' should be used. Like— Five miles is not a long distance.
 When discussing distance, amount, money, etc., and considering them as a collective
 unit or a whole, they are treated as singular and thus, the verb used with them should
 be singular.
- 11. Whereas, 'Abdication' means to renounce the throne, 'Addiction' refers to a habit or dependency, and 'Adoration' means deep love or respect, which don't fit in this context.
- 12. D) **Irons in the fire** (idiom) Having multiple tasks to complete एक समय में कई कार्यों में प्रतिबद्ध होना
- 13. 'No substitution required', 'taken for ease', and 'taken as granted' are incorrect in this context. 'Taken for ease' and 'taken as granted' don't have a clear meaning, and 'No substitution required' is incorrect because the underlined segment has a grammatical error.

B) 'As a consequence of' का use होगा क्योंकि "as a consequence of" का अर्थ होता है किसी कारण से। Sentence में इसे इस तरह use किया जा रहा है कि किसी कारण से (उसकी बीमारी के चलते) उसने काम समय पर पूरा नहीं किया। इसलिए 'As a consequence of' यहाँ सही है। जबिक 'Subsequent for' का अर्थ होता है बाद में के लिए, 'In consequence to' grammatically सही नहीं है, और 'On account' अधूरा और असंगत है, जो इस context में सही नहीं है।
 - 'As a consequence of' should be used because it means due to a particular reason. The sentence is implying that due to a reason (his illness), he could not complete the work on time. Therefore, 'As a consequence of' is the correct choice here. Whereas, 'Subsequent for' means later for, 'In consequence to' is not grammatically correct, and 'On account' is incomplete and out of context, making them inappropriate for this sentence.

20. A) **RSPQ**

- R: This sentence provides the overarching context for the whole paragraph the havoc caused by rains in Himachal Pradesh and specifically in Shimla.
- S: The term "heavy precipitation" aligns with the "rains" mentioned in sentence R. This sentence continues from the general topic of havoc caused by rains in Shimla by giving a specific example of where and how the havoc manifested itself in the Summer Hill area leading to flash floods and the collapse of a temple.
- P: After describing the effects of heavy precipitation in the Summer Hill area (sentence S), it's logical to move to another impact of the rain in a different part of Shimla, Krishnanagar in this case.
- Q: Sentence P introduced the topic of landslides with a specific example in Krishnanagar. Sentence Q broadens that to discuss landslides around Shimla in general. Hence, there's a progression from the specific to the general regarding landslides, making it logical to put Q after P.
- 21. C) Fallacy' का use होगा क्योंकि इसका अर्थ है "भ्रम या गलत धारणा।" Sentence है: "The biggest fallacy of society today is that... we live in a burnout society." यहाँ बात एक गलत विश्वास की हो रही है, इसलिए 'fallacy' सही है। जबकि 'Verity' (सत्य), 'Certainty' (निश्चितता) और 'Discrepancy' (अंतर/विरोधाभास) इस context में अर्थ नहीं देते।
 - 'Fallacy' will be used because it means a "false belief or misconception." The sentence is: "The biggest fallacy of society today is that... we live in a burnout society," which fits as it talks about a mistaken notion. Whereas, 'Verity' means truth, 'Certainty' means something definite, and 'Discrepancy' means inconsistency, none of which convey the idea of a mistaken belief here.
- 22. D) 'Thrives on' का use होगा क्योंकि sentence present tense में है: "This is one that thrives on excess positivity..." यहाँ subject "one" singular है, इसलिए verb भी singular form "thrives" होगा। जबिक 'Thrive on' base form है जो बिना auxiliary fit नहीं होता, 'Thriving on' participle form है जो यहाँ structure तोड़ देगा, और 'Throve on' past tense है जबिक sentence present truth बता रहा है।
 - 'Thrives on' will be used because the sentence is in present tense: "This is one that thrives on excess positivity..." The subject "one" is singular, so the singular verb "thrives" is required. Whereas, 'Thrive on' (base form) cannot be used without an auxiliary, 'Thriving on' (participle) breaks the sentence structure, and 'Throve on' (past tense) shifts the meaning to the past, which is not intended here.
- 23. B) 'Relentless' का use होगा क्योंकि sentence है: "a culture of overproduction and relentless achievement." यहाँ बात लगातार, कभी न रुकने वाली उपलब्धि की हो रही है, जो burnout society की पहचान है। जबकि 'Compassionate' (दयालु) meaning से मेल नहीं खाता, 'Cloaked'

(छिपा हुआ) context से असंबंधित है, और 'Equanimous' (संतुलित/शांतचित्त) इसका उल्टा अर्थ देता है।

- 'Relentless' will be used because the sentence is: "a culture of overproduction and relentless achievement," meaning continuous and never-ceasing pursuit of success, which leads to burnout. Whereas, 'Compassionate' means kind, 'Cloaked' means hidden, and 'Equanimous' means calm/balanced—none of which fit the context of excessive pressure and achievement.
- 24. A) '**Discrepancy'** का use होगा क्योंकि sentence है: "This discrepancy is felt most in the education ecosystem." यहाँ 'discrepancy' का मतलब है अंतर या असंगति, जो burnout society और education system में अनुभव किया जाता है। जबकि 'Mutual' (पारस्परिक) relation बताता है, 'Concord' (सहमति/मेल) positive meaning देता है, और 'Guile' (चतुराई/धोखाधड़ी) context से बिल्कुल unrelated है।
 - 'Discrepancy' will be used because the sentence is: "This discrepancy is felt most in the education ecosystem," referring to the gap or inconsistency experienced. Whereas, 'Mutual' refers to something reciprocal, 'Concord' means harmony, and 'Guile' means deceit—none of which fit the context of imbalance or inconsistency here.
- 25. D) **Dilemma'** का use होगा क्योंकि sentence हैं: "The dilemma is that we are a part of the educational process..." यहाँ 'dilemma' का अर्थ है कठिन स्थिति या जटिल समस्या, जो burnout और शिक्षा प्रणाली के बीच संबंध को व्यक्त करता है। जबिक 'Munificence' (उदारता/प्रसाद), 'Resolution' (संकल्प/निर्णय) और 'Tenacity' (दृढ़ता/अडिगता) context में अर्थहीन हैं और situation को व्यक्त नहीं करते।
 - 'Dilemma' will be used because the sentence is: "The dilemma is that we are a part of
 the educational process...," highlighting the complex or difficult situation caused by
 burnout in education. Whereas, 'Munificence' means generosity, 'Resolution' means
 determination/decision, and 'Tenacity' means persistence—none of which convey the
 idea of a problematic.
