Amoral embrace: On the U.S. and the Syrian President

The U.S. appears to have given a free pass to Sharaa in Syria

For Ahmed al-Sharaa, the founder of al-Qaeda's Syria branch, and now the President of Syria, his recent visit to the White House has marked a remarkable turnaround in his career. From commanding an outfit responsible for suicide bombings and targeted killings, and carrying a \$10 million bounty on his head, Mr. Sharaa, who until recently was known as Abu Mohammed al-Golani, is now a very close partner of Washington. After their meeting, U.S. President Donald Trump said that he "gets along with him". In December, only weeks after Mr. Sharaa's Hayat Tahrir al-Sham (HTS) toppled the secular Ba'athist regime of President Bashar al-Assad and seized Damascus, the U.S. lifted the bounty on the former jihadist commander. Earlier this week, Mr. Trump granted Syria wide exemptions on sanctions, and pressed Congress to repeal a 2019 law that imposed harsh penalties on the country, while Syria promised to join the war against the Islamic State. Mr. Sharaa has also signalled his desire to improve ties with Israel, America's closest ally in West Asia, even as Israel grabbed more Syrian territories in the Golan region after Mr. Assad's fall. Reports suggest the U.S. is preparing its presence at an airbase in Damascus as it brokers a Syria-Israel security pact. The message is clear: Syria, under Mr. Sharaa, seeks entry into the U.S.-led regional order, and Washington is reciprocating enthusiastically.

While allowing a country of 25 million people battered by western sanctions, foreign interventions and civil war, to join the regional economic mainstream is welcome, what troubles many is Mr. Sharaa's not-so-distant past. He was Abu Bakr al-Baghdadi's choice to open al-Qaeda's Syria branch. He split with Baghdadi when the latter founded the Islamic State in the early 2010s, and remained loyal to Ayman al-Zawahiri's al-Qaeda. Mr. Sharaa began to distance himself from al-Qaeda only after his forces captured Idlib, which became the hub of anti-Assad factions. As the ruler of Idlib, he maintained close ties with Türkiye. In November 2024, his HTS launched a rapid offensive against the Syrian army, which was badly hurt by Israeli bombings, and captured Damascus. Soon after, he was embraced by regional and western governments alike. While Mr. Sharaa has promised to build an inclusive Syria, the country has witnessed at least two massacres against minorities — against Alawites and the Druze. His attempts to centralise power through sham elections have deepened sectarian divides. Transnational jihadists within the HTS continue to operate freely. But the U.S., once vocally concerned about the human rights situation in Syria under Mr. Assad, appears to have given a free pass to Mr. Sharaa. If he is rehabilitated without accountability for his past and scrutiny of his present rule, Syria's wounds will remain unhealed, keeping it on the brink for years to come.

- Q: Q is a specific example of a non-professional reward, and it would follow naturally after S, which is a general statement about non-professional rewards. Q gives a personal touch to the paragraph by giving the author's personal experience

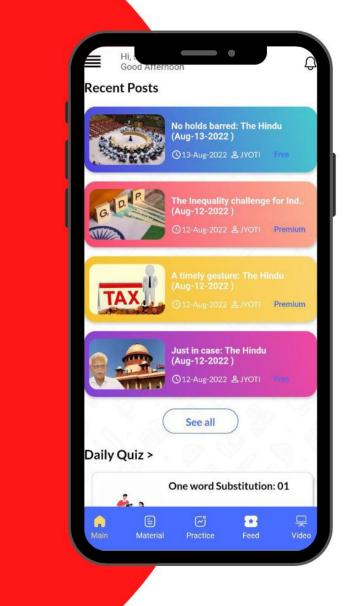

 - Microbes (noun) Microscopic organisms, especially bacteria, viruses, and fungi. सूक्ष्मजीव
 - Virus (noun) A microscopic infectious agent that can only replicate within the cells of living hosts. वायरस
 - Bacteria (noun) Single-celled microorganisms that can exist either as independent (free-living) organisms or as parasites. बैक्टीरिया
- 19. C) 'a book' के बदले 'the book' का प्रयोग होगा क्योंकि यहाँ पुस्तक को 'on the table' से स्पष्टीकरण किया गया है, जिससे यह पुस्तक विशेष बन जाती है।
 - 'a book' will be replaced by 'the book' because the book is specified by the phrase 'on the table,' making it a specific book. Therefore, the definite article 'the' should be used.
- 20. A) 'Bland' को चुना जाएगा क्योंकि 'Bland' का अर्थ होता है स्वादहीन। Sentence में बताया गया है कि उसे सूप स्वादहीन लगा, इसलिए 'Bland' यहाँ सही है। 'Blend' का अर्थ है मिलाना, 'Blent' एक archaic शब्द है और 'Blunt' का अर्थ है क़ंद, जो इस context में सही नहीं है।
 - 'Bland' should be used because it means lacking in flavor. The sentence states that he found the soup tasteless, making 'Bland' appropriate here. 'Blend' means to mix, 'Blent' is an archaic form, and 'Blunt' means not sharp, which are incorrect in this context.
- 21. D) Asserted' का use होगा क्योंकि "asserted" का अर्थ होता है दृढ़तापूर्वक कहना या दावा करना। sentence में कहा गया है कि मंत्री ने यह स्पष्ट किया कि किसी भी संवेदनशील क्षेत्र में कोई समझौता नहीं हुआ, इसलिए 'asserted' यहाँ सही है। जबकि 'Refuted' का अर्थ है खंडन करना, 'Contradicted' का अर्थ है विरोधाभास करना, और 'Rebutted' का अर्थ है तर्क देकर खारिज करना—ये सब यहाँ context में फिट नहीं होते।

- 'Asserted' will be used because it means to state firmly or declare with confidence. The
 sentence says that the Minister firmly stated that no compromise was made in any
 sensitive sector, so 'asserted' is correct here. Whereas 'Refuted' means disproved,
 'Contradicted' means opposed, and 'Rebutted' means argued against, none of which fit
 this context.
- 22. C) Was made' का use होगा क्योंकि "compromise" singular है और sentence passive voice में है। sentence में कहा गया है कि किसी भी संवेदनशील क्षेत्र में कोई समझौता नहीं किया गया, इसलिए 'was made' यहाँ सही है। जबकि 'Were made' plural noun के साथ आता है, 'Have made' active voice है (जिसमें subject की आवश्यकता होती है), और 'Has made' भी active voice है और subject mismatch करता है—ये सब इस context में सही नहीं हैं।
 - 'Was made' will be used because "compromise" is singular and the sentence is in
 passive voice. The sentence says no compromise was made in any sensitive sector, so
 'was made' fits correctly. Whereas 'Were made' is used for plural nouns, 'Have made' is
 active voice requiring a subject, and 'Has made' is also active voice with subject
 mismatch, none of which fit this context.
- 23. A) Seemed' का use होगा क्योंकि "seemed" का अर्थ होता है प्रतीत होना या ऐसा लगना। sentence में कहा गया है कि मंत्री केवल कृषि और श्रम-प्रधान निर्माण क्षेत्रों को ही संवेदनशील मान रहे हैं, इसलिए यह केवल ऐसा प्रतीत होता है कि वे इन्हें संवेदनशील मानते हैं, इसलिए 'seemed' यहाँ सही है। जबकि 'Vanished' का अर्थ है गायब हो जाना, 'Receded' का अर्थ है पीछे हटना, और 'Faded' का अर्थ है कमजोर या फीका पड़ना—ये सब इस context में सही नहीं हैं।
 - 'Seemed' will be used because it means appeared or gave the impression. The sentence says the Minister appeared to be counting only agriculture and labour-intensive manufacturing as sensitive sectors, so 'seemed' fits correctly. Whereas 'Vanished' means disappeared, 'Receded' means moved back, and 'Faded' means weakened, none of which fit in this context.
- 24. B) On' का use होगा क्योंकि "impact on" एक standard collocation है और इसका अर्थ होता है किसी चीज़ पर प्रभाव डालना। sentence में कहा गया है कि FTA का प्रभाव भारत के अन्य संवेदनशील डिजिटल क्षेत्र पर पड़ा, इसलिए 'on' यहाँ सही है। जबकि 'At' स्थान या समय के लिए प्रयोग होता है, 'For' लाभ या उद्देश्य के लिए और 'To' दिशा या लक्ष्य के लिए होता है—ये सब इस context में सही नहीं हैं।
 - 'On' will be used because "impact on" is a standard collocation meaning to affect something. The sentence mentions that the FTA's impact is on India's other sensitive digital sector, so 'on' fits correctly. Whereas 'At' is used for place or time, 'For' indicates benefit or purpose, and 'To' indicates direction or target, none of which fit in this context.
- 25. A) Has gone' का use होगा क्योंकि subject singular/plural (impact) के साथ present perfect tense में है और sentence बताता है कि कोई official comment या media scrutiny अभी तक नहीं हुई। इसलिए 'has gone' यहाँ सही है। जबकि 'Have went' grammatically गलत है (should be 'have gone'), 'Was

gone' past tense में है और continuous/ongoing स्थिति नहीं दिखाता, और 'Were gone' plural के लिए past tense है—ये सब इस context में सही नहीं हैं।

• 'Has gone' will be used because the subject (impact) is singular/plural and the sentence is in present perfect tense, indicating that no official comment or media scrutiny has occurred so far. Whereas 'Have went' is grammatically incorrect (should be 'have gone'), 'Was gone' is past tense, and 'Were gone' is past tense for plural, none of which fit in this context.
